EXECUTIVE SUMMARY:
<p>The PCC is requested to confirm her approval for the following grant awards:</p> <ul style="list-style-type: none"> • Up to £299,601 to seven local community organisations for the period May 2022 to March 2025 through the 2022/25 Make Notts Safe Youth Diversion Thematic Grants. • Up to £315,150 to eight local community organisations for the period May 2022 to March 2025 through the 2022/25 Make Notts Safe Hidden Harm Thematic Grants. <p>The above funding would come from the Community Safety Grant in the main with the VRU contributing £50,000 a year from their core budget.</p>

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)
<p>In January 2022 the PCC launched her new Make Notts Safe grants schemes. The Make Notts Safe Thematic grants provide multi-year funding for third sector community based organisations to enable local delivery against key priorities. Funding in relation to two themes – Youth Diversion and Hidden Harm – opened in January 2022.</p> <p>In relation to Youth Diversion the aim of the themed funding was to prevent crime by supporting targeted projects and initiatives to divert at risk young people away from crime and anti-social behaviour. In relation to Hidden Harm the aim of the themed funding was to protect vulnerable people from hidden harm by supporting targeted projects and initiatives to reduce hidden harm.</p> <p>Applications were invited from community organisations with all applications undergoing a robust assessment process in which all applications were assessed by a minimum of two officers from the OPCC against a scored matrix. Applications were then discussed at an independent Stakeholder Panel which included senior police officers, representatives from the City and County Council as well as representatives from the Youth Justice teams and Youth Services. The panel agreed the final list of recommendations which went to the PCC. The PCC agreed the project to be funded and provisional awards were made. Following the provisional awards successful applicants were invited to Stage Two which involved the development of the organisations theory of change and outputs and outcomes measurements. Following completion of this final funding awards were confirmed.</p> <p>Seven projects were successful in securing Youth Diversion Thematic Grants and eight projects were successful in securing Hidden Harm thematic Grants.
