### EXECUTIVE SUMMARY:

This proposal seeks approval for an additional 31 Police Officers to be recruited in the financial year 2022-23. This is over and above the existing uplift allocations which will be appropriately funded via the Home Office.

The original allocation was 357 additional Police Officers via the uplift programme which will now be 388 Police Officers. The additional 31 officers will be recruited in March 2023 rather than the first quarter of 23/24 financial year.
