As the newly appointed Chief Constable already has a vehicle provided at their current Force, the proposal is to transfer that vehicle to Nottinghamshire for £25k. This will be met from slippage in the existing fleet capital programme for 2022/23. Should the outturn show that not enough slippage occurred the capital programme will be increased accordingly.
