EXECUTIVE SUMMARY:
This Policy applies to the Scheme of Delegation, appended to this Decision Record

INFORMATION IN SUPPORT OF DECISION: (e.g., report or business case)
<p>Section 1 of the Police Reform and Social Responsibility Act 2011 and Policing Protocol 2011 sets out the Police & Crime Commissioners responsibilities as a single elected individual in public officer.</p> <p>The Police and Crime Commissioner for Nottinghamshire is minded to ensure the lawful and efficient discharge of their duties, by providing for decision-making to be carried out through the most appropriate structure and at the appropriate level.</p> <p>The statutory powers of the Commissioner to arrange for others to exercise those functions are set out in S18 of the Act. In addition, by virtue of s14, Schedule 1 to the Act, the Commissioner may do anything which is calculated to facilitate, or is conducive or incidental to, the exercise of those functions.</p> <p>The Commissioner may not delegate functions to:</p> <ul style="list-style-type: none"> • A constable; • The Mayor's Office for Policing and Crime; • The Deputy Mayor for Policing and Crime; • The Mayor of London; • The Common Council of the City of London; • Any body which maintains a police force; and, • A member of staff of the above.

Nottinghamshire Police and Crime Commissioner – Notice of Decision

The Commissioner cannot delegate certain functions to anyone else. These functions are:

- Issuing the Police and Crime Plan;
- Appointing, suspending and requiring the Chief Constable to resign;
- Calculating the budget requirement.

This Scheme of Delegation has been designed to optimise delivery of the Commissioner's functions, for instance, where the Commissioner is temporarily abstracted from duties of office. However, the Scheme cannot supersede any legislative requirements.

This intention of this Scheme is to support the effective and efficient management and delivery of the function of the Office of the PCC through the effective use of the PCC's delegable powers.
