<b>EXECUTIVE SUMMARY:</b>
The Commissioner is requested to approve the allocation of additional funding of up to £5,000 to provide sensory equipment for the Adult SARC.


<b>INFORMATION IN SUPPORT OF DECISION: (eg report or business case)</b>
<p>For 2022/2023 only, £5,000 PCC funding is intended to be match funded by NHS England to provide a total of up to £10,000 for sensory equipment for the Adult SARC.</p> <p>The funding will be used to provide sensory based equipment for the Adult SARC building that will be selected according to survivors' needs. Survivors will be consulted by the SARC staff on what the money should be spent on, further supporting a victim focused and victim led SARC building. A list of potential items will then be sent to the PCC for approval.</p> <p>Total PCC funding to be approved is £5,000.</p>
