EXECUTIVE SUMMARY:
<p>This decision form seeks approval to award £6414.48 to Nottingham Business Improvement District for the provision of safe space pledge audits. Funding is to be granted from the Late Night Levy fund.</p>

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)
<p>As part of the remaining late-night levy / SWAN funding the working group discussed the appetite to expand a twice-yearly audit of safe space pledge venues to assess awareness and training needs. This will re-enforce the safe pledge and ensure continued growth with businesses around the need to develop safe working practices ensuring it is embedded within the signed-up businesses.</p> <p>The audit will be undertaken by Business Liaison Officers, working for the Nottingham Business Improvement District, and is expected to cover 151 venues.</p> <p>The timescales for the delivery of this activity are expected to be February 2023 – March 2024.</p>
