EXECUTIVE SUMMARY:
<p>The PCC is requested to confirm her approval for the following grant awards:</p> <ul style="list-style-type: none"> £100,040.97 to two community organisations for the period May 2023 to March 2025 through the 2022/25 Make Notts Safe Rural Crime Thematic Grants.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)
<p>In January 2022 the PCC launched her new Make Notts Safe grants schemes. The Make Notts Safe Thematic grants provide multi-year funding for third sector community-based organisations to enable local delivery against key priorities. Funding in relation to rural Crime – opened in January 2023.</p> <p>In relation to Rural Crime the aim of the themed funding was to improve the local response to rural crime and the experience of victims of crime and ASB in rural communities.</p> <p>Applications were invited from community organisations with all applications undergoing a robust assessment process in which all applications were assessed by a minimum of two staff members of the OPCC against a scored matrix. Applications were then discussed at an independent Stakeholder Panel which included senior police officers and a representative from the Safer Nottinghamshire Board. The panel agreed the final list of recommendations which went to the PCC. The PCC agreed to fund two projects and provisional awards will be made. Funding awards are provisional based on organisations undertaking and engaging with the development of the project's theory of change and outputs and outcomes measurements. Following completion of this funding will be confirmed.</p> <p>Two projects were successful in securing Rural Crime Thematic Grants. Brief details of the grant's recipients are detailed below – further information about these grants is available in the PCCs website. Please note that all the grant funding is subject to organisations meeting specific funding criteria.</p>
