EXECUTIVE SUMMARY:
<p>The PCC subscribes to Police Digital Services (PDS) for the purposes of accessing nationally agreed contracts for specific services. The Adobe provision is one such service negotiated and contracted on behalf of all Forces by PDS.</p> <p>This notice is for transparency purposes to notify the entering of a 3-year agreement for the supply of Adobe software licensing via a Service Level Agreement with Police Digital Services. The period of contract will be 20th April 2023 to 19th April 2026. The total contract value £283,643 (£94,547 per annum). If additional licenses are deployed charges will be made under True Up provisions.</p>
