EXECUTIVE SUMMARY:
<p>The PCC is requested to approve the award of a contract to Red Snapper Managed Services for provision of unlimited access to the Intervention Hub to be utilised for Community Resolutions from 1st July 2023 to 30 June 2025.</p> <p>The total cost of up to £50,000 is broken down as follows:</p> <ul style="list-style-type: none"> • £25,000 from 1st July 2023 to 30th June 2024 • £25,000 from 1st July 2024 to 30th June 2025


INFORMATION IN SUPPORT OF DECISION: (eg report or business case)
<p>Legislative changes to Out of Court Disposals (OOCs) come into place nationally (initially scheduled for 1 April 2023, now delayed until later in 2023). The Act establishes a statutory two-tier framework for OOCs. Police forces will retain use of the Community Resolution as the only non-statutory informal disposal.</p> <p>Red Snapper provide a unique online digital platform (the Intervention Hub) which holds evidence-based interventions. These would be utilised for all Community Resolutions.</p> <p>This provision will enhance the application of a rehabilitative condition to community resolutions, supporting a reduction in reoffending and increase victim satisfaction.</p>
