<b>EXECUTIVE SUMMARY:</b>
<p>In lieu of the pension remedy activity required (McCloud judgement) there needs to be a variation in the agreement to XPS for payment milestones in relation to this additional work that needs completing.</p> <p>The additional cost to Nottinghamshire is £584,971 between now and 1<sup>st</sup> April 2025 and is part of the nationally agreed amounts.</p> <p>There may be opportunity that this, or a proportion of this, is funded centrally but until further detail the assumption is for it to be self funded.</p>
