<b>EXECUTIVE SUMMARY:</b>
<p>Further to DR 2023.048 which detailed that £35,000 was allocated for Serious Violence Crime prevention work in Nottingham City during the period 1st April 2023 to 30th September 2023, the PCC is requested to confirm a further £35,000 to be distributed amongst the three serious violence crime prevention projects to deliver initiatives from 1<sup>st</sup> October 2023 to 31<sup>st</sup> March 2024.</p>
