### EXECUTIVE SUMMARY:

The purpose of this notice is to seek approval for the award of a call-off contract to Breaking Barriers Building Bridges (BBB) for the provision of Detached Youth Work services in Nottingham City Centre under the previously established Detached Youthwork Framework.

The call off contract will run for an initial 6-month period with 2 optional 12 month extensions.

### INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The Framework didn't originally provision for Nottingham City Centre however, since the establishment of the framework, further funding has been received to allow for this provision in this area. We therefore conducted a further competition under the framework inviting the 4 suppliers on the framework to bid for this opportunity.

This has been procured in accordance with the Public Contracts Regulations 2015.

### FINANCIAL INFORMATION

Up to £54,130 is known to be available for the first 6 months and then up to £108,260 pa thereafter as detailed in the table below (subject to the contract being extended accordingly).
