EXECUTIVE SUMMARY:

The purpose of this notice is to seek approval to establish a 48-month Co-Commissioned ISVA and CHISVA Framework and enter into formal contractual arrangements for up to 6 years with the following 2 providers.

Lot 1: Nottinghamshire Sexual Violence Support Services
 Lot 2: IMARA CIO (CHISVA)

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The original ISVA and CHISVA contracts ran from April 2018 to 30th June 2020 with two optional extension years (July 20 to June 21 and July 21 to June 22). A further 21-month extension was undertaken via a single tender award (July 2022 to March 2024).

The intention is to establish a Framework Agreement for the provision of ISVA and CHISVA for Nottinghamshire. This Framework is being established under the Light Touch Regime. Nottingham City Council and Nottinghamshire County Council will also have the ability to place call-off contracts under this Framework Agreement.

FINANCIAL INFORMATION

Budget is earmarked for the initial term (1st April 2024 to 31st December 2025) and will include core PCC funding as well as specific MOJ ISVA funding which has been awarded to PCCs. The profile is shown below.
