EXECUTIVE SUMMARY:

Following a full recruitment exercise, the PCC recently appointed an Interim Chief Executive and Monitoring Officer (CEMO) for the OPCC who was confirmed by Nottinghamshire Police and Crime Panel on 8 January 2024, in accordance with the provisions of the Police Reform and Social Responsibility Act 2011.

Once appointed, the appointee was subject to a 3 month notice period. However, the PCC has agreed with the appointee’s current employer, the PCC for South Yorkshire, that she will be released early from her notice period, in return for a transition phase which will see her working in both OPCCs for a short period under a local policing body collaboration provision, supported by a Section 22A Collaboration Agreement and a Secondment Agreement.

The appointee will be employed by the Nottinghamshire OPCC from 26 February 2024, and seconded into South Yorkshire OPCC for two days a week from 26 February to 2 May 2024. South Yorkshire PCC will reimburse the Nottinghamshire PCC for the salary and expense costs of Nottinghamshire OPCC’s CEMO for the days she is seconded into South Yorkshire OPCC.

The PCC is requested to approve the Collaboration and Secondment Agreements to enable the OPCC’s new Chief Executive and Monitoring Officer to be seconded into South Yorkshire OPCC two days a week from 26 February to 2 May 2024.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

This arrangement between the PCCs is provided for under a (policing body collaboration provision) Collaboration Agreement, made under section 22A of the Police Act 1996 (as amended). The national s.22A has been followed as appropriate to this situation. In addition, the

standard secondment agreement used by Nottinghamshire OPCC has been adapted for this situation. Independent legal advice has been provided to both PCCs.

The Seconded will work in each OPCC for at least 2 days per week for the 10 week period of the secondment. A Senior Leadership Team in each OPCC, including a Deputy Monitoring Officer, provides resilience for the days the Seconded is working in the other OPCC.


FINANCIAL INFORMATION

The OPCC staff budget includes funding for a full time CEMO and therefore will achieve a cost saving for the period of the secondment due to the reimbursement.


