EXECUTIVE SUMMARY:

The purpose of this notice is to seek approval to enter formal contractual arrangements for the provision of Self Drive Vehicle Hire with Enterprise Rent-A-Car UK Ltd from 18th March 2024 until 17th March 2027 with the option of 2 x 1 year extension periods.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The proposed contract is for the provision of Self Drive Vehicle Hire to provide the Force with hire vehicles up to 3.5T for various lengths of time and on occasion for hire of up to 1 year. The force had a previous agreement in place with Enterprise Rent-A-Car UK Ltd.

A competitive tendering procedure was conducted under a compliant CCS Framework for the above requirements, with Enterprise Rent-A-Car UK Ltd submitting the most economically advantageous tender as part of this process.

FINANCIAL INFORMATION

The estimated total cost over the initial three-year contract period is £190,454.04 excl. VAT, however this will vary according to actual demand. This estimate is provided for within Force budget.


