#### **EXECUTIVE SUMMARY:**

Proposal of changes to the Revenue Budget 2023/24 between the Chief Constable, Joint Services and OPCC.

### OPCC changes to income budget:

- 1. £20,000.00 for Offender to Rehab increase in income from County Council and Mitie
- 2. £25,000.00 for Restorative Nottinghamshire increase in income from HMPPS
- 3. £300,000.00 for DA Perpetrator increase in income from Home Office
- 4. £333,112.00 for Pathfinder increase in income from NHS England (NHSE).

### OPCC changes to expenditure budget:

- 1. £20,000.00 for Offender to Rehab increase in expenditure
- 2. £25,000.00 for Restorative Nottinghamshire increase in expenditure
- 3. £300,000.00 for DA Perpetrator increase in expenditure
- 4. £58,300.00 for NHSE Pathfinder increase in expenditure
- 5. £274,812.00 for contribution to NHSE Pathfinder reserve
- 6. £12,474.75 for Pay Award share increase in expenditure being higher than predicted

### Chief Constable changes to income budget:

- 1. £5,891,304.90 for Pay Award increase in income from Home Office
- 2. £19,006.67 for Occupational Health increase in income for charges for Police Services

### Chief Constable changes to expenditure budget:

- 1. £5,815,914.59 for Pay Award increase in expenditure being higher than predicted
- 2. £19,006.67 for Information Services increase in expenditure for charges for Police Services
