
EXECUTIVE SUMMARY:
<p>A sexual violence needs assessment is required to identify the impact of increased waiting lists on survivors of sexual violence accessing specialist services. This has been discussed and agreed with the Joint Sexual Violence Governance group. Whilst funding is currently in place for sexual violence support services, a substantial reduction in funding is projected from April 2025. The needs assessment will inform commissioning priorities from 2025 onwards.</p> <p>The assessment will contain qualitative research in the form of focus groups set up with the assistance of specialist sexual violence support service providers and an independent VAWG consultant. These focus groups will include voices of survivors and case studies, hearing from those who are waiting for, are receiving, have received service, and those not in contact with services. Focus groups will also be set up with practitioners from these services to obtain their views and experiences.</p> <p>The outcomes of the qualitative research will be published alongside quantitative research being carried out by analysts from the Office for the Police and Crime Commissioner.</p> <p>The PCC is requested to authorise up to £10,000 to fund this research, subject to receiving a satisfactory workplan.</p>

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)
<p>The sexual violence needs assessment will contain a mixture of quantitative and qualitative research in order to identify key themes in order to make recommendations for specialist sexual violence support services and inform commissioning priorities from April 2025 onwards.</p> <p>The assessment will be completed in conjunction with providers themselves to ensure the safety of the survivors taking part.</p>
