#### **EXECUTIVE SUMMARY:**

The J9 initiative is a nationally recognised and locally acknowledged initiative to enhance responses to domestic abuse, increase access to services and decrease barriers to accessing support. The approach is simple and accessible for anyone to understand and implement. The J9 initiative looks to create a network of safe spaces in communities and ambassadors who understand the basic principles of:

- Where to signpost a community member living with domestic abuse
- How to respond if they are looking for help in ways that won't increase risk to themselves
  or others

The initiative is primarily aimed at organisations and businesses in communities, and community members, but can be extended to charities, local authority departments and public sector provisions to create a whole community response.

The proposal is for Equation to provide a dedicated worker to develop community links, promote the J9 initiative in the target areas/ community of interest, develop campaigns and deliver training on safe spaces.

The project will run from 1st April 2024 to 31st March 2025.

The PCC is requested to authorise £31,210 of grant funding for this project.

### **INFORMATION IN SUPPORT OF DECISION:** (eg report or business case)

The aims and objectives of the J9 initiative are in line with the PCC's strategic priorities of preventing crime and protecting people from harm, and supporting victims, witnesses and communities. It also supports the Nottinghamshire VAWG strategy.

The initiative will promote and enable a whole community response to domestic abuse.
