TITLE:	College of Policing Review into Nottinghamshire Police's handling of Valdo Calocane case

EXECUTIVE SUMMARY:

The Commissioner announced publicly on 30 January 2024 that she would commission the College of Policing ("the College") to conduct an independent external review ("the Review") into Nottinghamshire Police's response to the killings and attempted murders committed by Valdo Calocane on 13 June 2023.

The purpose of the Review is to identify lessons that can be learned for Nottinghamshire Police, and wider policing, so that they may be shared and implemented. The Review's Terms of Reference are in the final stages of development.

The Commissioner is requested to approve the award of funding to the College of Policing to conduct the review, subject to satisfactory agreed Terms of Reference and a value for money budget.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The PCC commissioned the College in accordance with her statutory function of holding the Chief Constable of Nottinghamshire Police to account, as provided by paragraphs 15, 17(c) and 17(j) of the Policing Protocol 2011.¹ The PCC considers the College to have the required independence from Nottinghamshire Police, necessary knowledge of policing standards and guidance, and essential expertise in improving policing practice through learning.

¹ The Policing Protocol Order 2011, SI 2011 No. 2744. Paragraph 15: The PCC within each force area has a statutory duty and electoral mandate to hold the police to account on behalf of the public. Paragraph 17(c): the PCC may hold the Chief Constable to account for the performance of the force's officers and staff. Paragraph 17(j): the PCC may hold the Chief Constable to account for the exercise of the functions of the persons under the direction and control of the Chief Constable

The Review's Terms of Reference have been informed by the serious concerns raised by the victims and bereaved families and victims, who are being consulted on the Terms of Reference.


The PCC has received assurance from the College that it will take into account the separate and independent IOPC investigation and care will be taken to ensure no duplication, and to avoid prejudicing the misconduct investigation and any disciplinary hearings.


