## **EXECUTIVE SUMMARY:**

The capital budget for 2023/24 was £12,041k, the outturn at the end of the financial year was £8,040k resulting in an underspend of £2,279k and a carry forward request of £1,722k.

Carry forward is requested where it has not been possible to complete a project in the financial year in which the budget was allocated.

Supply chain issues and contractor issues have played a major part in the delivery of the capital programme therefore carry forward of £1,387k into 2024/25 and £334k into 2025/26 is requested to support the continuation of projects through to completion.
