### **EXECUTIVE SUMMARY:**

To seek approval to enter formal contractual arrangements with Mustard Seeds Associates CIC for an initial period of 6 months from 1 June 2024 to 30 November 2024 with an optional 9-month extension.

The purpose is to offer timely counselling services for Another Way referrals aged between 14-24 years of age.

## **INFORMATION IN SUPPORT OF DECISION:** (eg report or business case)

The Another Way Project is funded by the Youth Endowment Fund and Home Office. It works with 14–24-year-olds, many of whom have adverse childhood experiences and or trauma. They have a high need for mental health support and diagnosis of underlying conditions and are a group that is often reluctant to access services. Take up is adversely affected by long waiting times. This service will ensure timely support is provided with expected beneficial outcomes of improved mental health and reduced violence and offending. To procure more specialist support where that is required, and to arrange for assessments such as (but not limited to) SEND, dyslexia or ADHD where a need is identified through work with an individual, or at the request of the Another Way support teams.

The service is also part of the agreement with Youth Endowment Fund.

A tender process was conducted with the successful bidder being Mustard Seeds Associates CIC.

#### FINANCIAL INFORMATION

The cost for the 6 month contract is £53,200, this is within the Another Way budget 2024/25.
