EXECUTIVE SUMMARY:

The purpose of this notice is to seek approval to award a contract to Vauxhall Motors Ltd for the purchase of a total of 34 Replacement General Purpose Vehicles (one-off purchase).

The proposed contract is for the provision of Replacement General Purpose Vehicles to provide the Force with a variety of new vehicles to replace the current fleet. Those vehicles identified as in need of replacement are due to a combination of age and mechanical issues.
