<b>EXECUTIVE SUMMARY:</b>
The purpose of this notice is to seek approval to award a contract to Vauxhall Motors Ltd for the purchase of a total of 34 Replacement General Purpose Vehicles (one-off purchase).

<b>INFORMATION IN SUPPORT OF DECISION: (eg report or business case)</b>
The proposed contract is for the provision of Replacement General Purpose Vehicles to provide the Force with a variety of new vehicles to replace the current fleet. Those vehicles identified as in need of replacement are due to a combination of age and mechanical issues.
A call-off procedure was conducted under a compliant BlueLight Commercial Framework ref BLC-FLEET-0001 for the above requirements, with Vauxhall Motors Ltd providing the vehicles.
