EXECUTIVE SUMMARY:

The purpose of this notice is to seek approval to enter formal contractual arrangements for Uninterruptable Power Supply (UPS) replacement and maintenance with 2BM Limited. This will be for a period of 3 years, with the option to extend for 2 periods of 1 year each, taking the maximum contract term to 5 years.

INFORMATION IN SUPPORT OF DECISION: (eg report or business case)

The proposed contract is for the replacement of UPS equipment and maintenance of the same. The maintenance of other existing units is also included.

A competitive tendering procedure was conducted under a compliant YPO framework for the above requirements, with 2BM Limited being the most economically advantageous submission received.

FINANCIAL INFORMATION

The total value over the initial 3-year term is £247,962.49 (excl. VAT) with a further £20,437.92 (excl. VAT) split over the 2 optional extension periods. These values will vary slightly according to the spare parts required during maintenance visits. Funds have been earmarked in reserves to cover the equipment supply, with the ongoing maintenance met from the revenue budget.
