

<b>EXECUTIVE SUMMARY:</b>
<p>A request has been made by the National Police Coordination Centre (NPoCC) via His Majesty's Government to support the policing response to the 2024 Paris Olympics through supplying Police Officers for an estimated maximum period of two weeks to a police force outside the United Kingdom.</p> <p>The full cost of the deployment will be met by the donee police force and there is no net cost to the Nottinghamshire Police fund.</p> <p>Details of the specific deployment are retained within the Office of the Police and Crime Commissioner and are not published within this Decision Notice. The Chief Constable is satisfied that those details are operationally sensitive for the reasons set out in article 2, paragraph (2)(a) to (c) of the Elected Local Policing Bodies (Specified Information) Order 2011 (as amended) in that publication would be against the interests of national security; and/or might jeopardise the safety of any person; and/or might prejudice the prevention or detection of crime, the apprehension or prosecution of offenders, or the administration of justice.</p> <p>Extensive work has been ongoing to ensure a low risk, safe and effective deployment of UK officers to France.</p> <p>Under section 26 of the Police Act 1996 (as amended) permission is needed from the Police and Crime Commissioner (PCC) for police officers to be deployed overseas in a duty capacity. This will also allow the necessary insurances to be granted for the deployment period.</p> <p>This deployment has been approved by the Chief Officer Team.</p>
