A tunnel under Stonehenge and transforming roads into 'smart motorways' are among the projects in the government's £15bn **Road Investment Strategy**, the details of which were announced by the Department for Transport and the Treasury. Money for the new initiative, which covers investment lasting up to 2021, was first announced last year. It will triple investment in the roads by the end of the decade, the government said, with the announcement coming as a report from the RAC Foundation predicts there could be an additional seven million road users in England and Wales – taking the total to 43 million – within 20 years.

## [Councils 'failing to deliver disabled-friendly homes'](#)

Up to 300,000 disabled people will be left on housing waiting lists this winter, with many of them having to 'make do' in accommodation that does not meet their needs, a new report has revealed. The '**No Place Like Home**' study by Leonard Cheshire Disability found that 84% of councils have 'no information' about wheelchair-accessible housing. This, according to the charity, is leaving disabled people on housing waiting lists living in severe discomfort.

A series of council-led anti-fraud projects have been given a share of £16m funding to clamp down on social housing tenancy cheats, business rates evasion, procurement fraud and social care and health tourism.

Immigrants from the EU will have to work in Britain for four years before they are eligible to claim benefits, David Cameron proposed in a major speech on immigration today.

## **Winners of Transformation Challenge Award announced**

The government has announced the names of 73 successful bidders for the Transformation Challenge Award, with a total of £89.4m to be distributed. In total, the 73 successful bids involve 287 partners including 122 local authorities and 165 other organisations across the public, private and voluntary sectors.

## **Universal Credit may not prove value for money – NAO**

The Department for Work and Pensions (DWP) twin-track approach to rolling out its 'live service' while simultaneously developing its new 'digital service', means Universal Credit may not be value for money regardless of how it is implemented and the cost of doing so.

## **Councils fail to collect £4.55bn in council tax and business rates**

The local spending watchdog said local authorities in England gathered on average 97% of the council tax they were owed in 2013-14, down 0.4% on the previous year. Rates varied from 91.7% up to 99.3% in some authorities. Had the previous year's collection rate been maintained, councils would have collected around an additional £94m in 2013/14.

## **Panel calls for councils to get greater flexibility to deliver services**

Strong performing councils should be given greater flexibility over how services are delivered and funded, and a £5bn transformation fund should be created from existing pots of cash, according to a new report from the independent Service Transformation Challenge Panel.

## **Gritting salt stockpiles rise in 18% of councils, poll reveals**

Almost a fifth of councils are raising gritting salt stockpiles this winter, with 49% of town halls preparing to share supplies – a poll reveals.

## **Council uncovers illegal flats with trees growing through walls**

Council officers have repossessed 'appalling and dangerous' flats in Clapham, one of which had a tree growing through the wall.

## **Survey shows public support for tackling empty homes**

Nearly three-quarters (74%) of the general public would like their local council to prioritise bringing empty homes back into use, according to a new survey.

## **Pension funds to pool £10bn assets**

Two Local Government Pension Scheme (LGPS) funds are to pool their combined assets of over £10bn.

## **1,400 flood defence projects win funding**

Over 1,400 flood defence projects have been chosen to receive government investment, in moves expected to improve protection for 300,000 homes.

## **Councils fail to agree voluntary mergers**

Just six of the 22 local authorities in Wales have submitted voluntary merger plans in time for the government's deadline.

## **Report calls for radical reforms to council budgeting**

Councils should radically reform the way they approach budgeting, focusing on outcomes rather than outputs, a new report is arguing.

## **Proposals to amend regulations relating to the use of capital receipts**
