Criminal Justice and Courts Bill

This is a Bill to make provision about how offenders are dealt with before and after conviction; to amend the offence of possession of extreme pornographic images; to make provision about the proceedings and powers of courts and tribunals; to make provision about judicial review; and for connected purposes.

SI 2014/2816 Immigration (Removal of Family Members) Regulations 2014

In force on 14 November 2014, these Regulations make provision under section 10(10)(b) of the Immigration and Asylum Act 1999 ('the 1999 Act'), as amended by section 1 of the Immigration Act 2014, in respect of the service of notice to family members of a person who is liable to be or has been removed under section 10(1) of the 1999 Act, as amended, prior to the removal of those family members.

SI 2014/2771 Immigration Act 2014 (Commencement No 3, Transitional and Saving Provisions) Order 2014

This Order is the third commencement order made under the Immigration Act 2014 ('the Act'). Article 2 lists the provisions of the Act which came into force on 20 October 2014, subject to saving provision in articles 9, 10 and 11.

SI 2014/2704 Offender Management Act 2007 (Dissolution of Probation Trusts) Order 2014

In force on 31 October 2014, this Order dissolves all 35 existing probation trusts across England and Wales.

SI 2014/2676 Road Vehicles (Registration and Licensing) (Amendment) (No 2) Regulations 2014

These regulations, other than regulation 4, come into force on 31 October 2014. Regulation 4 comes into force on 9 December 2014.

SI 2014/2634 Borders, Citizenship and Immigration Act 2009 (Commencement No 3) Order 2014

In force 27 October 2014, this Order brings into force section 41(5) of the Act to the extent that it specifies the procedure for regulations made under section 41(1)(bza) of the British Nationality Act 1981.

SI 2014/2559 Equality Act 2010 (Equal Pay Audits) Regulations 2014

In force 1 October 2014, these Regulations are made under section 139A and 207(1) and (4) of the Equality Act 2010 ('the Act').

SI 2014/2523 Safety of Sports Grounds (Designation) Order 2014

In force 10 October 2014 this Order designates the City Football Academy Arena, occupied by Manchester City Football Club Limited, as a sports ground requiring a safety certificate under the Safety of Sports Grounds Act 1975.

SI 2014/2485 National Minimum Wage (Amendment) (No 2) Regulations 2014

In force 1 October 2014, these Regulations make amendment to the national minimum wage.

2. Strategic policing and crime news

[May to consult with victims before appointing new child abuse inquiry chair](#)

The home secretary is to consult victims before appointing a new chair of the troubled child abuse inquiry after Fiona Woolf, the second person appointed to the post, resigned amid speculation about her links to Lord Leon Brittan.

[HMIC: West Mids has six weeks to address child protection](#)

Her Majesty's Inspectorate of Constabulary has imposed a strict time limit for West Midlands Police to develop a child protection action plan, following a recent inspection. The ultimatum comes after inspectors found a number of causes for concern including what it deemed to be an unsatisfactory response to difficult cases, alongside a 'lack of understanding' about the extent of child sexual exploitation across the force area.

[New PCC elected for South Yorkshire](#)

Alan Billings has been elected as South Yorkshire's new Police and Crime Commissioner following a by-election held last week. Billings, the Labour candidate and a retired Anglican priest, won with over half of the vote, beating UKIP representative Jack Clarkson (32%) into second place. As with many previous PCC elections, the turn-out on the day was disappointingly low, with less than 15 per cent casting their vote.

[Greater Manchester to get a mayor in return for devolution package](#)

Greater Manchester is set to receive a multi-billion pound package of devolution from the government, in return for agreeing to institute a directly elected mayor for the region. The mayor will have powers over transport, housing, planning and policing. The deal offered by the government includes a £350m Metrolink tram extension to Trafford Park, control of the region's £500m skills budget, £300m in house building funding, power to combine health and social care funds together and a pledge to make Manchester a science capital.

The Home Secretary first announced a number of measures in August 2014 to improve the way police use stop and search powers and to make the use more transparent. One of the measures was to present stop and search information for all forces via maps on the police.uk website.

[Council becomes first to use new anti-social powers](#)

Oldham has become the first to use [new anti-social behaviour powers](#) to evict tenants from a property. The council, Greater Manchester Police and First Choice Homes Oldham have used the new measures to close a property in Roundthorn for three months following complaints it was used as a drugs den.

The police station representative validation exercise which began on 27 May 2014 has been completed and the Legal Aid Agency have requested help making final checks on their spreadsheet. Providers should double check that any representative being used for police station advice is listed on the register of probationary and accredited representatives. The statement was made by Assistant Chief Constable Richard Bennett at the National Black Police Association's AGM, which took place in London this week.

Metropolitan Police officers have taken part in nearly 1,000 community activities across the capital in a week long initiative to bring the force closer to the public it serves. The activities

– which have seen the participation of around 3,200 officers and PCSOs - included hosting football matches, attending faith groups, and visiting schools and skate parks. Also involved were around 200 partner organisations alongside nearly 400 police cadets.

Better Care Fund boosted to £5.3bn to deploy 18,000 community workers

The Better Care Fund is to be boosted to £5.3bn a year to help join up health and social care services, the government announced last night. The extra £1.5bn, on top of the original £3.8bn, is reportedly to come from more pooling of local budgets – it is not new money.

Hospital anti-gang scheme wins government approval

Crime Prevention Minister Norman Baker has praised a pioneering project that tackles gang violence by placing youth workers in hospital A&Es. The scheme, which is steered by [youth-work charity Redthread](#), offers support to teenage victims of violence with the aim of helping them withdraw from the gang lifestyle.

Officer commended following sword attack

An officer who disarmed a man who was trying to slash him with a samurai sword has won this year's Police Federation national bravery award. The Met's Sgt Stephen Brown tackled his aggressor using only his CS spray and baton, after the man continually ignored orders to put the weapon down on Christmas Eve 2012.

'A COLLABORATIVE FUTURE FOR COUNTIES AND DISTRICTS'

New Local Government Network (NLGN) have called on all political parties to rule out the possibility of local government reorganisation for the next parliament in their new report, which indicates that the spectre of unitary status is still holding back the potential for local collaboration. In some local places partners continue to focus on the potential for nationally imposed reorganisation instead of focusing on the challenging business of working together. Furthermore, NLGN argue that counties and districts should be encouraged to form combined authorities with a new duty to integrate their services to improve outcomes and reduce costs. The research argues that, while unitary status can save substantial sums of money, the process of reorganisation can be long-winded, expensive and often harms performance in the short term.

NEW RESEARCH ON COMMUNITIES' NEIGHBOURHOOD PLANNING PUBLISHED

A new report entitled 'User Experience of Neighbourhood Planning in England Research', the first primary research of its kind into neighbourhood planning has been published by Locality and conducted by the University of Reading. It suggests that communities have largely been able to access the skills, knowledge and support they need for neighbourhood planning. The aim of the research was to inform future approaches towards neighbourhood planning, including how to improve it and increase its effectiveness, as well as the shape of future support offered to neighbourhoods.

FUTURE PUBLIC SERVICES EXAMINED

The CBI have published a new report on the future public services spending, arguing that the government should establish a new fiscal rule once the deficit has been eliminated ensuring that public spending never outstrips revenue receipts. The report argues that public services require fundamental re-shaping to better meet public needs, rather than simply cutting

budgets. Following the NHS Five Year Forward View, the report says that integrating social care and health services by combining budgets and commissioning systems would save money and improve clinical outcomes by moving care from hospitals into homes and communities.

REFORMING THE UK BORDER AND IMMIGRATION SYSTEM

The House of Commons Public Accounts Committee has published its twentieth report entitled 'Reforming the UK border and immigration system' which examines the abolishing of the UK Border Agency in March 2013 and the following transfer of responsibilities and functions to the Home Office.

The mental health charity Mind has published a report that examines the spending on public mental health in England.

The National Audit Office (NAO) have published a new report from their series of departmental overviews on the performance of the Department for Work and Pensions (DWP) during 2013-2014.

Review calls for tri-boroughs to have own chief executives

The tri-borough should scrap its shared chief executive in order to deliver improvements to the joint working arrangements, an independent review has recommended.

Surrey wins best council website award

Surrey County Council has won website of the year in the 2014 Socitm Awards. The judges of the award gave the council's website a four star rating, saying it contained 'excellent' information and the mobile site was 'very good'.

Ex-council worker jailed for fraud and theft

A former employee of Chelmsford City Council has been jailed for fraud and theft totalling over £200,000.

WEALTH OF THE NATION EXAMINED

The Smith Institute have published their new report that analyses policies for wealth distribution in the UK. The publication explores the implications for public policy from the new Office of National Statistics (ONS) data source on wealth distribution in Britain and future trends in savings, longevity, property prices and inheritance. The authors highlight implications for the public policy debate focussing primarily on intergenerational transfers including inheritance, as well as issues relating to housing and consumer debt.

4. Consultations

Consultation on the Government's policy on importation of oxycodone

The Home Office has launched a public consultation on proposed amendments on licensing imports of oxycodone in the UK. The consultation runs until 20 November 2014 and is the second consultation on the Government's policy on the import of oxycodone to the UK.

Planning and travellers: proposed changes to planning policy and guidance

Proposed changes to planning policy and guidance, ensuring fairness in the planning system, and strengthening protection of the green belt and countryside. Closes 23 November.

Open consultation on local policing accountability, leadership and ethics

The Committee on Standards in Public Life (the Committee) has commenced an open consultation on local policing – accountability, leadership and ethics. Closes 30 November 2014.

Robbery guideline consultation

The Sentencing Council has launched a consultation on the draft guideline on robbery. The consultation closes 23rd January 2015.

Plans for Secure College rules consultation

Proposed merger of the local justice areas in North Yorkshire

This consultation was published on 1 October and closes on 31 December. Yorkshire.

Ketamine rescheduling consultation

The Home Office is seeking views on the Advisory Council on the Misuse of Drugs (ACMD) recommendation to reschedule ketamine to Schedule 2 of the Misuse of Drugs Regulation (as amended) (the 2001 Regulations). The consultation runs until 3rd November 2014.
