## 2. Strategic policing and crime news

[Home Affairs Select Committee \(HASC\) Report – inquiry into PCCs](#)

The report finds that it is still too early to tell whether or not the introduction of PCCs has been a success. It says the concept of PCCs is still on probation. It says that police and crime panels have struggled to understand their powers and define their role. The report states that many of the difficulties faced by PCCs could have been avoided if they had been given the opportunity to find their feet before commencing their job. It also states that the appointment of deputies needs to be more transparent and changes are required regarding the removal or suspension of chief constables.

[Home Affairs Select Committee \(HASC\) Report – Counter Terrorism](#)

The oversight system for the intelligence services requires strengthening and the responsibility for counter-terrorism policing should be transferred from the Metropolitan Police Service (MPS) to the National Crime Agency (NCA), a Parliamentary report has concluded.

## **Police and prison officer killers to face life in prison**

Anyone who kills a police or prison officer in the course of their duty will face spending the rest of their lives behind bars, Justice Secretary [Chris Grayling](#) has announced. The changes to the law being made by the Ministry of Justice will mean that judges will start by considering a whole life term when deciding the sentence for killing either a police or prison officer in the course of their duty. This is an increase from the current starting point of a 30-year minimum term. Judges would retain the discretion to determine the appropriate sentence in each case - a whole life term will not be mandatory.

## **3. Developments and reports**

### **Cautious optimism**

On Monday, the Home Affairs Select Committee published a [report on Police and Crime Commissioners](#), stating that "PCCs have provided greater clarity of leadership for policing within their areas", but that it is too early to tell whether their introduction has been a success.

### [Hate crime: Report finds significant progress in reducing hate crime](#)

A report on the progress made in the past 2 years has been published. Achievements include: better education of secondary school pupils, improved recording by police and work with major internet service providers in the UK and USA to reduce the harm caused by hate material on the internet. The report also discusses the spike in anti-Muslim sentiment following the murder of Lee Rigby.

## [Councils reaching "end of the road" for managing cuts through efficiency savings says LGA](#)

Popular local services like leisure facilities, children's centres and pothole repairs are likely to bear the brunt of funding cuts over the next two years, a survey of councils' financial strategies suggests. Following £10 billion worth of cuts in the past three years many councils are starting to reach "the end of the road" for saving money through becoming more efficient. Research carried out by the Local Government Association suggests that the impact of spending reductions will start to become increasingly visible over the next two years, as councils tackle a further £10 billion cut in government funding.

Department for Transport – National Statistics. From January to March 2014 (Quarter 1) All Motor Vehicle Traffic increased by 4.1% when compared to the same quarter in 2013.

Comparing quarter 1 (January to March) 2014 with the same quarter of the previous year:

- all motor vehicle traffic increased by 4.1 %, to 78.5 billion vehicle miles.
- car and LGV traffic increased by 3.8% and 7.3% respectively.
- traffic volumes increased across all road classifications.

In each case the organisation failed to respond within the statutory time limit of 20 working days, or after 40 working days where the law allows a public authority to extend the deadline.

The LGA has re-launched the national shared services compendium and map which now shows that at least 337 councils across the country are engaged in 383 shared service arrangements resulting in £357 million of efficiency savings. At least 95 per cent of all English councils are sharing services with other councils.

These have had to be revised code to ensure they reflect the changes introduced in the ASBCP Act. These changes will maintain the protection of the UK border as well as continuing to respect individuals' human rights. ## **Review of the operation of Sections 135 and 136**

### [HMIC provides assurance that chief constables are having regard to the Strategic Policing Requirement – but finds that more needs to be done](#)

This inspection examined how well police forces have established the arrangements that the Strategic Policing Requirement requires them to have in place to counter a number of specified threats to national security and public safety. It is based on data and documentary evidence provided by all 43 police forces in England and Wales in July 2013. It includes supporting fieldwork, conducted in 18 forces, and in nine Regional Organised Crime Units (ROCs).
