Queen's Speech 2014

Her Majesty's speech to both Houses of Parliament at the State Opening of Parliament 2014 – introduced the following 11 Bills:

- Armed Forces (Service Complaints and Financial Assistance) Bill
- Childcare Payments Bill
- Infrastructure Bill
- Modern Slavery Bill
- National Insurance Contributions Bill
- Private Pensions Bill
- Pensions Tax Bill
- Recall of MPs Bill
- Serious Crime Bill

This legislation will strengthen the ability of law enforcement agencies to disrupt serious and organised crime and strengthen and update laws to protect vulnerable individuals at risk of child cruelty, sexual exploitation and female genital mutilation

- Small Business, Enterprise and Employment Bill
- Social Action, Responsibility and Heroism Bill

The following Bills will be published in draft:

- Protection of Charities Bill
- Riot (Damages) Bill
- National Park Authorities (Elections) Bill

Immigration Act 2014 has received Royal Assent.

The Immigration Bill has received Royal Assent making way for a series of reforms which will ensure our immigration system is fairer to British citizens and legitimate migrants and

tougher on those with no right to be here. The Immigration Act 2014 contains 77 clauses and makes fundamental changes to how our immigration system functions.

[Chief Officers work on a new body to replace ACPO](#)

A team representing all chief officer ranks has been working hard on behalf of all ACPO members to develop proposals for a modernised, improved coordinating body. All chief officers will be consulted on the proposals, which will be debated at ACPO conference. Members will be balloted on the proposals.

[Trial of Child Advocate scheme launched](#)

On 4 June Minister for Modern Slavery, Karen Bradley, announced that Barnardo's would deliver trials of the new advocate scheme to provide a specialist advocate trained in the specific needs of victims of child trafficking. It starts in August.

[College of Policing publishes direct entry superintendents' training programme](#)

Under this new scheme, seven police forces are recruiting up to 20 leaders from outside the service to join at a senior rank. Their 14 month training programme will be followed by three months in a supervised and supported superintendent environment in early 2016. They will also be expected to lead a community partnership project.

[Home Office circular 10/2014](#)

This Home Office circular relates to the new offences around forcing someone to marry. The offences were included in the Anti-social Behaviour, Crime and Policing Act and came into

effect today (16 June). The circular summarises the offences of forcing someone to marry and breaching a Forced Marriage Protection Order, signposts the related guidance and gives contact details for the Home Office Forced Marriage Unit.

An Independent Police Complaints Commission (IPCC) review on the handling of discrimination complaints by three metropolitan forces found significant failings. The report was published on 5 June.

[Ban on NBOME and benzofurans comes into force](#)

A dangerous group of drugs that puts users at high risk of overdose was permanently banned from Tuesday 10th June. NBOME substances are permanently controlled as Class A under the Misuse of Drugs Act 1971. Other drugs affected by this new order include benzofurans which, like NBOMw, have been marketed as so-called 'legal highs'.

The Equality and Human Rights Commission has launched an inquiry that will look at suicide, homicide and accidental deaths of people in psychiatric hospitals, prison and police custody in England and Wales, to identify what can be done to prevent more tragedies. A report on the findings will be published in spring 2015 with recommendations for action needed by the relevant bodies.

[Thousands of children missing from council care](#)

Figures revealed under the Freedom of Information Act show that between January 2012 and December 2013 there were 24,320 missing children reported. The majority were teenagers, however, dozens were much younger. The figures included a one-year-old girl who disappeared in July 2013 and still remains missing. Of 138 councils in England and Wales, Kent County Council topped the list, with 458 children disappearing on 2,623 occasions.

Wolverhampton City Council has said under proposed plans the neighbourhood wardens will become the latest casualties of austerity cuts implemented by the authority. The council has been forced to make £123m worth of cuts to bring spending under control. This has included cutting 2,000 jobs over the next five years, reducing the opening hours of libraries, shutting local youth clubs, charging admission to Wolverhampton's art gallery, imposing Sunday parking charges, and increasing council tax. Now, the council has announced 18 neighbourhood wardens will be scrapped, saving a total of £480,000 a year.

The College of Policing in partnership with the national policing lead for criminal justice, Chief Constable Chris Eyre, is consulting on new bail principles to support police use of pre-charge bail. The consultation is open until 19th June 2014.

HMIC provides assurance that chief constables are having regard to the Strategic Policing Requirement – but finds that more needs to be done

This inspection examined how well police forces have established the arrangements that the Strategic Policing Requirement requires them to have in place to counter a number of specified threats to national security and public safety. It is based on data and documentary evidence provided by all 43 police forces in England and Wales in July 2013. It includes supporting fieldwork, conducted in 18 forces, and in nine Regional Organised Crime Units (ROCU).
