**The Police (Promotion) (Amendment) Regulations 2015**

**SI 2014/3285 Crime and Courts Act 2013 (Commencement No 1) (England and Wales) Order 2014**

In force **2 March 2015**, this Order is the first commencement order relating only to England and Wales made under the Crime and Courts Act 2013. It brings into force in England and Wales, section 56 of that Act together with Schedule 22 to that Act, which deal with drugs and driving.

**SI 2015/82 The Sexual Offences Act 2003 (Prescribed Police Stations) Regulations 2015**

These Regulations, which came into force on **25 February 2015** and extend to England and Wales only, revoke and replace the Sexual Offences Act 2003 (Prescribed Police Stations) Regulations 2013 (SI 2013/300).

**SI 2015/142 The Road Vehicles (Construction and Use) (Amendment) Regulations 2015**

These Regulations, which come into force on **9 March 2015**, amend the Road Vehicles (Construction and Use) Regulations 1986 (the 1986 Regulations).

**SI 2015/138 The Dangerous Dogs Exemption Schemes (England and Wales) Order 2015**

This Order, which came into force on **3 March 2015**, extends to England and Wales.

**SI 2015/212 The Football Spectators (Corresponding Offences) (Revocation) Order 2015**

This Order, which comes into force on **11 March 2015**, revokes the Orders in Council listed in the Schedule to the Order.

**SI 2015/206 The Proceeds of Crime Act 2002 (External Investigations) (Scotland) Order 2015**

This Order, which comes into force on **16 March 2015**, extends to Scotland only.

**SI 2015/232 The Misuse of Drugs (Designation) (Amendment) (England, Wales and Scotland) Order 2015**

This Order, which comes into force on **11 March 2015**, extends to England and Wales and Scotland.

## **SI 2015/ 231 The Misuse of Drugs (Amendment) (England, Wales and Scotland) Regulations 2015**

These Regulations, which come into force on **11 March 2015**, extend to England and Wales and Scotland.

## **SI 2015/228 The Regulation of Investigatory Powers (Communications Data) (Amendment) Order 2015**

This Order, which came into force on **12 February 2015**, amends the Regulation of Investigatory Powers (Communications Data) Order 2010 (the 2010 Order).

## **SI 2015/217 The Counter-Terrorism and Security Act 2015 (Code of Practice for Officers exercising functions under Schedule 1) Regulations 2015**

These Regulations came into force on **13 February 2015**.

## **SI 2015/215 The Misuse of Drugs Act 1971 (Amendment) Order 2015**

This Order which comes into force on **11 March 2015**, brings certain drugs under the control of the Misuse of Drugs Act 1971 ('the Act').

## **SI 2015/242 The Motor Vehicles (Wearing of Seat Belts) (Amendment) Regulations 2015**

These Regulations came into force on **3 March 2015**.

The Home Affairs select committee have criticised police use of out-of-court disposals, stating they are used inappropriately in up to 30% of cases. In a report published today, the committee raised concerns that persistent and serious offences were being dealt with through out-of-court disposals when they ought to have been prosecuted at court. ACS research has shown that 1 in 4 shop thieves are repeat offenders, contributing to a £35m annual loss to the sector.

The JCNSS has published its latest report, looking at the next National Security Strategy which is expected to be published after the General Election. In its report the Committee said that the next NSS should look hard at the UK's place within the international order, and what strategic thinking should underpin its actions over the next five years. It also needs to influence the Comprehensive Spending Review, to ensure that the Government can make fully-informed decisions on security-related spending. The next NSS should set clear objectives for the UK's future place in the world and geopolitical priorities, and inform the Strategic Defence and Security Review's assessment of the means required to achieve them.

## **Council admits failure to protect young people from sexual grooming**

More than 350 young people in Oxfordshire have been victims of sexual exploitation over the last 15 years, according to a serious case review. The review, published by the Oxfordshire Safeguarding Children Board, found Oxfordshire County Council had failed to act upon the child sex grooming scandal, which saw seven men imprisoned for a total of 95 years as part of Operation Bullfinch.

## **Social workers 'deeply disturbed' by findings of serious case review**

The serious case review into [the grooming of young girls in Oxfordshire](#) will have 'far-reaching consequences' for the way child sexual exploitation is handled, according to social workers. The College of Social Work says the [findings of the review](#) are 'deeply disturbing' and should lead to changes in the way exploitation is dealt with by frontline staff and leaders.

## **Council staff could face prison for failing to protect children**

Public officials who fail to act on suspicions of child abuse could face five-year prison sentences under new measures unveiled. Prime minister, David Cameron, said council chiefs, social workers and teachers who fail to protect children could face criminal action to help 'eradicate the culture of denial'.
