SI 2014/3207 Proceeds of Crime (Disclosure Orders: Confiscation Investigations) (Specified Person) Order 2014

In force 1 January 2015, this Order specifies the Director of the Serious Fraud Office as a prosecutor for the purposes of section 357(8)(b) of the Proceeds of Crime Act 2002 ('the Act').

SI 2014/3192 Crime (International Co-operation) Act 2003 (Commencement No 6) Order 2014

This Order came into force on 3 December 2014 and is the sixth commencement order made under the Crime (International Co-operation) Act 2003. It brought into force section 90 of, and Schedule 4 to, that Act.

SI 2014/3191 Criminal Justice and Data Protection (Protocol No 36) (Amendment) Regulations 2014

These Regulations came into force on 3 December 2014 simultaneously with, and make minor amendments to, the Criminal Justice and Data Protection (Protocol No 36) Regulations 2014 (SI 2014/3141) in relation to the transposition of a number of provisions of Council Framework Decision 2003/577/JHA of 22 July 2003 on the execution in the European Union of orders freezing property or evidence (OJ L 196, 2.8.2003, p45), Council Framework Decision 2006/783/JHA of 6 October 2006 on the application of the principle of mutual recognition to confiscation orders (OJ L 328, 24.11.2006, p59), Council Framework Decision 2006/960/JHA of 18 December 2006 on simplifying the exchange of information and intelligence between law enforcement authorities of the Member States of the European Union (OJ L 386, 29.12.2006, p89), Council Framework Decision 2008/977/JHA of 27 November 2008 on the protection of personal data processed in the framework of police and judicial cooperation in criminal matters (OJ L 350, 30.12.2008, p60), Council Framework Decision 2009/315/JHA of 26 February 2009 on the organisation and content of the exchange of information extracted from the criminal record between Member States (OJ L 93, 7.4.2009, p23), and Council Framework Decision 2009/829/JHA of 23 October 2009 on the application, between Member States of the European Union, of the principle of mutual recognition to decisions on supervision measures as an alternative to provisional detention (OJ L 294, 11.11.2009, p20).

Conservatives pledge to cap public sector redundancy payments

In a new manifesto pledge, the Tories will commit to capping pay-outs at £95,000 for workers in the public sector. Only those earning less than £27,000 will be exempt from the cap.

Northern councils have highest proportion of children in care

In a top 10 list of councils with the highest proportion of children in care, Blackpool topped the list with 152 children in care per 10,000, followed by Wolverhampton with 136.

Neighbourhood planning process to speed up

Local authorities will have 13 weeks to make a decision on applications to create a 'neighbourhood area', with this reduced to eight weeks where applications follow a parish boundary.

Poor communication and staffing issues led to Powys home care problems

The reorganisation of home care services in Powys ran into difficulty because of problems including poor communication and staffing issues, according to an independent review.

Poor households face council tax increases warn council leaders

English councils have been put in an 'impossible position' by being forced to either hike council tax bills for low-income working age residents or reduce services still further, council chiefs have stormed.

Councils face up to £100m in road repairs backlog

Councils are facing a huge backlog of road repairs, with some authorities needing up to £100m to complete work, according to new figures.

Shrinking council budgets force projects to be axed

Nearly three in four councils have had to cancel or postpone a planned building project in the last two years, research has found.

Taxpayers waiting twice as long on phone to contact HMRC

Official figures published by HM Revenue and Customs show that average waiting times for its contact centre telephone queues reached 10 minutes and 53 seconds in September - more than double the five minutes and 21 seconds recorded at the same point in 2013.

£6bn funding for potholes not enough says LGA

The £6bn of funding for councils to fix potholes announced by the Department for Transport is not enough to "bridge the overall funding gap" according to the Local Government Association, which says "there is still a very long way to go to bring the nation's roads up to scratch".

Government launches consultation into mandatory reporting of FGM

The Government has launched a consultation seeking views on how best to introduce

mandatory reporting of female genital mutilation (FGM). The consultation runs to 12th January 2015.

Local government finance settlement 2015 to 2016

Triennial Review of Information Commissioner's Office

This review is now open for comment and runs until 16th January 2015.

Robbery guideline consultation

The Sentencing Council has launched a consultation on the draft guideline on robbery. The consultation closes 23rd January 2015.

Changing existing regulations for an emergency alert system

In the [Strategic Defence and Security Review](#), we committed to evaluate options for rapidly notifying people affected by an emergency. This would help them protect themselves. In autumn 2013 the government, working with local emergency response agencies and the mobile phone networks, completed the [mobile alerting trials for public emergencies](#). The trials found that a 'location-based SMS' service would be the most effective way to alert people in affected areas. However existing Privacy and Electronic Communications Regulations 2003 may restrict the operation of such a system. Closing date, 26th January 2015.

Proposal to use a Legislative Reform Order in forming a combined authority or economic prosperity board

The government is proposing to seek Parliament's approval to make amendments to [Part 6 of the Local Democracy, Economic Development and Construction Act 2009](#), relating to combined authorities and economic prosperity boards, through a Legislative Reform Order. Closes on the 26th January 2015.

Prevent duty

The Counter-Terrorism and Security Bill, which is currently before Parliament, seeks to place a duty on specified authorities (identified in full in Schedule 3 to the bill, and set out in this draft guidance) to have due regard to the need to prevent people from being drawn into terrorism. Closes 30th January 2015.

31st January 2015 - Guidance for healthcare professionals on information sharing

Schedule 7 to the Terrorism Act 2000: draft code of practice

Schedule 7 to the Terrorism Act 2000 ('Schedule 7') allows an examining officer to stop and question individuals travelling through ports, airports, international rail stations or the border area. When necessary they may also detain and search individuals. The aim is to determine whether that person appears to be someone who is or has been concerned in the commission, preparation or instigation of acts of terrorism. Closes on 30th January 2015.

This joint inspection was published today by Her Majesty's Inspectorate of Constabulary (HMIC) and Her Majesty's Crown Prosecution Service Inspectorate (HMCPSI). It sets out 11 recommendations for improvement, including better training and additional guidance for staging the sensitive interviews.

The Government published its review of whether Intercept could be introduced as evidence. The review concluded that the introduction of intercept as evidence could only be achieved at significant cost and that the benefits of introducing intercept as evidence would be uncertain. Indeed, on some assumptions, the review concluded that the introduction of intercept as evidence may lead to a decrease in successful prosecution. The review therefore concluded that intercept as evidence should not be introduced at this time, but that the Government would keep it under review.
