1. Policy and Practice

[Police and Crime Commissioners – Lessons For the Second Generation – 28th April 2016](#)

Deloitte report explores lessons for the 2nd term of PCCs based on interviews 10 incumbent Commissioners. Report concludes that many PCCs have shown gravitas, tenacity and resilience to establish credibility and authority in the face of limited public interest and have brought local debates on policing to life. The report identifies 9 lessons for the next generation of PCCs;

- Get set for an engagement sprint to establish your presence quickly
- Recognise your mandate – the winning candidate has all the democratic authority they require
- Prepare for the evolution – be at the centre of local discussions on service integration and devolution
- Make the case for digital transformation – maximise opportunities to improve efficiency and interaction
- Think wider than policing – particularly in relation to mental health and youth services
- Become master of your data – exploit data to improve resource allocation and decision making
- Focus on implementation, especially with partners and be clear on expectations for delivery
- PCC offices and police force leadership teams need to plan and manage political transition
- National and local politicians need to support the next generation of PCCs and champion the role

This includes new tools, capabilities and powers such as unexplained wealth orders (UWO), new powers for the National Crime Agency, plans to reform the Suspicious Activity Reports (SARs) regime and work to embed the Joint Money Laundering Intelligence Taskforce (JMLIT).

3. Research, Development and Statistics

Offender Management Statistics to December 2015 – Published 28th April 2016

While the total number of prisoners has remained relatively stable, the composition continues to change, with more serving longer determinate sentences and the number of new admissions and releases on temporary licence falling. Offender recalls continue to increase following the expansion of licence supervision to cover those receiving short term sentences. The total probation caseload increased by 11% in 2015.

Safety in Custody statistics – Published 28th April 2016

Latest official statistics report 290 deaths in prison custody in 2015/16, marking an 18% (+51) increase on 2014/15. The most notable increases were in the cases of self-inflicted deaths (+21) and deaths due to natural causes (+18). Reported incidents of self-harm in prison also increased by 25% in 2015, while assault incidents increased by 27% to 20,518 recorded incidents. Both serious assaults (2,813) and serious assaults on staff (625) increased by 31%.

Proven Reoffending Statistics to June 2014 – Published 28th April 2016

Ministry of Justice data shows that the overall proven re-offending rate remained relatively stable between 2003 and 2014 at around 26%, with around 131,000 out of 504,000 adult and juvenile offenders going on to commit a proven offence within a year from July 2013 to June 2014. Reoffending rates remain highest amongst adults serving sentences of less than 12 months (60%), adult theft offenders (43%) and people aged 10 to 17 (38%). While proven juvenile re-offending rates saw a marginal increase, the cohort has fallen by 70% since 2003.

Police Use of Taser statistics to December 2015 – Published 28th April 2016

Latest official statistics show 10,329 uses of Taser by police in 2015 marking a 2% increase on 2014 to a level similar to 2013. Uses which resulted in Taser being discharged (1,921) fell by 3%. Red-dot laser sight remains the most common form of Taser use accounting for 51% of all Taser uses. Data available at [police force level](#).

Police Use of Firearms statistics to March 2015 – Published 28th April 2016

Latest official statistics report 14,666 police firearms operations in 2014/15, marking a 2% reduction on the previous year. The number of Authorised Firearms Officers in England and Wales (5,647) also fell by 4%. The number of incidents in which police firearms were discharged remains low (6). Domestic Violence in England and Wales – 25th April 2016

Commons briefing paper examines definition and prevalence of domestic violence and civil and criminal remedies available for victims. The latest Crime Survey for England and Wales statistics indicate that 8.2% of women and 4% of men were estimated to have experienced domestic abuse in 2014/15, equivalent to an estimated 1.3 million female and 600,000 male victims nationally. National DNA Database statistics to March 2016 – Published 22nd April 2016

Latest official statistics show that details of 5,156,268 individuals are now retained on the National DNA Database, marking a 2.5% increase on March 2015, while the number of crime scene sample profiles retained has increased by 6.8% to 519,678.

Commercial Victimisation Survey 2015 – Published 28th April 2016

Survey indicated further reductions in crime against the wholesale, retail and agricultural sectors in 2015. Despite reductions in overall thefts, the levels and cost of shoplifting has seen no significant change on 2012. The majority of premises across all sectors surveyed are satisfied with the way police handle crime in their area. 40% of premises in the wholesale and retail sector experienced a crime in the last 12 months, compared to 24% of agricultural premises and 21% of premises in the construction sector.

[Crime Survey for England and Wales data to December 2015 – Published 21st April 2016](#)

CSEW indicates that crimes against households and adults saw a 7% decrease in 2015 on the previous year and by around 66% since its peak in 1995. Reductions in the last year have largely been driven by falls in theft offences (-7%) and criminal damage (-14%). Violent crime levels showed no statistically significant change. The proportion of respondents having experienced or witnessed ASB over the last 12 months has remained relatively stable since 2012 at around 28%. Results from a separate survey of crime against children aged 10 to 15 indicate that experience of violence and robbery amongst this group may have increased by 12% and 17% respectively over the last year.

[Police Recorded Crime to December 2015 published – 21st April 2016](#)

Total police recorded crime increased by 7% in 2015 compared to 2014. Increases have largely been impacted by improvements in crime recording practices, particularly in relation to "violence against the person" offences, which rose by 27%. Homicides increased by 11% from 517 to 573 in 2015, however this was skewed by increases in particular months spread across different police force areas. Offences involving knives or sharp instruments rose by 9%, partly reflecting improvements in recording procedures in some forces. Police recorded sexual offences also increased by 29% to the highest level on record (103,614), in part affected by improvements in recording and a greater willingness of victims to report. Fraud offences referred to the National Fraud Intelligence Bureau (NFIB) saw a further 4% increase but remain substantially under-reported. Police recorded ASB saw a further decrease of 8% in 2015, however it is recognised that the quality of recording and decision making can vary significantly between police forces. [Crime Outcomes to December 2015 published – 21st April 2016](#)

Available data indicates that in 2015, 14.8% of recorded crimes resulted in charge/summons or being taken into consideration, 8.3% resulted in a formal or informal out of court disposal and in 2.4% of cases the prosecution could not progress or it was not in the public interest. Conversely, suspects were not identified in the case of 52% of crimes and evidential difficulties on account of either the victim (13.2%) or suspect (9.1%) prevented a case progressing in the case of 22.3% of crimes. Note: Figures exclude crimes yet to be assigned an outcome.

[A&E department data indicates violent crime reductions are 'levelling off' – 20th April 2016](#)

Data collected by Cardiff University from 91 A&E departments and walk-in centres suggests that the decline in violence in England and Wales since 2008 may now have levelled off. Findings are consistent with the latest CSEW report. While the study did not look at specific reasons, researchers suggested that local authorities and police spending less money on monitoring real time footage from CCTV cameras in order to prevent incidents from escalating could be a potential factor. Professor Jonathan Shepherd, director of the University's Violence Research group, commented "Public health practitioners and policy makers responsible for tackling community violence in need to take note and consider refreshing current violence prevention initiatives".

[Insight Report: An Easy Target? – 19th April 2016](#)

CSEW analysis undertaken by Victim Support identifies disability or limiting long term illness as the single risk factor common across theft and violent crime victimisation. People with limiting disabilities are almost three and half times more likely to suffer serious violence and 1.6 times more likely be a victim of personal theft than adults without a limiting disability. Risk amongst this group has also increased by 3.7% over the past decade in contrast to trends involving the non-disabled population.

[Internet Watch Foundation Annual Report – 21st April 2016](#)

The Internet Watch Foundation's (IWF) Annual Report highlights an 118% increase in the number of illegal child sexual abuse images and videos being identified and removed from the internet over the last year and a 417% increase since the IWF were given approval to start proactively searching for online child sexual abuse imagery in April 2014. 68,092 reports were confirmed as illegal images or video in 2015.

4. Legislation

Enterprise Bill – Date for Royal Assent TBC

Make provision regarding promotion of enterprise and economic growth; restricting exit payments in relation to public sector employment; introduces apprenticeship commencement targets for public sector bodies with more than 250 employees and the establishment of an Institute to regulate quality.

Immigration Bill - Ping Pong stage – TBC

Make provision about the law on immigration and asylum; access to services, facilities, licences and work by reference to immigration status; language requirements for public sector workers; fees for passports and civil registration; provision about the Director of Labour Market Enforcement. [Final amendments](#) made 12th April.

Online Safety Bill - Lords Report stage - TBC

Private Members' Bill to make provision about the promotion and provision of online safety including parent education; requiring ISPs and mobile phone operators to provide a service that excludes adult content; require manufacturers to provide a means of filtering internet content; and regulate harmful on-demand material

Road Traffic Act 1988 (Alcohol Limits) (Amendment) Bill 2015-16 - Lords Report stage – 3rd reading TBC

Private Members' Bill to lower prescribed limit of alcohol in breath, blood and urine by 37%

Policing and Crime Bill - Commons Report stage – 3rd reading TBC

Make provision for Emergency Services Collaboration; Police complaints, discipline and inspection reform; changes affecting the police workforce and representative institutions; Police powers and PCCs; Firearms and alcohol licensing; and Miscellaneous provisions. Investigatory Powers Bill - Commons Committee stage – 3rd May 2016

Make provision about the interception, acquisition and retention of communications data and other bulk data for analysis and the use of equipment interference. Establish the Investigatory Powers Commissioner and other Commissioners and make provision about oversight arrangements; make further provision about investigatory powers and national security; amend s3 and s5 of Intelligence Services Act 1994. Private Members' Bill (17th March) to raise penalty for littering offences; provide for an offence that relates to allowing a dog to foul the land; and require local authorities to provide appropriate and convenient litter disposal

Rehabilitation of Offenders Bill - Second reading in Lords - TBC

Amendments to the Rehabilitation of Offenders Act 1974 introducing revised rehabilitation requirements

Prisons Bill - Announced as part of the Prime Ministers Prison Reform Speech – 8th Feb 2016

Draft Bill will make provision for new 'reform prisons'; transformation of the prison education system; new performance metrics / League Tables; new prison-based counter extremism programme; 'secure alternative academies' for young offenders; problem-solving courts; expanded use of tags / satellite tracking and new arrangements for women offenders with children

The Sentencing Council is consulting on a revised guideline for guilty plea sentence reductions to clarify the levels of reduction appropriate for the different stages at which the plea is entered. This follows data suggesting that levels of reductions in some cases appear to be higher than those recommended by the guideline.

Revising PACE codes C, D and H

Home Office consultation on draft codes of practice C, D and H under the Police and Criminal Evidence Act 1984 (PACE). Changes to codes C and H predominantly concern use of interpretation services via live-link where the interpreter's physical presence is not necessary, consistency between Codes C and H regarding electronic reporting, appropriate adult roles and the detention of children and adults and female detainees. Changes to code D bring it up to date with other subsequent guidance and provisions and guidance, including the EU Directive on translation and interpretation, the Equality Act 2010, the Protection of Freedoms Act 2012 (retention of fingerprints and DNA) and Border Force operational guidance.
