## 1. Policy and Practice

### [Examining the case for justice devolution](#) – 14<sup>th</sup> December 2016

Report from independent think tank GovernUp suggests that top-down reform of criminal justice is failing and proposes that PCCs or directly elected Mayors should be given the tools and powers to join up services across an area in order to deal with the root cause of crime. Recommendations include devolving youth justice services, youth custody, responsibility for cautions and other out of court disposals and the adult prison budget for short sentenced prisoners and women prisoners to PCCs and directly elected mayors. The report also recommends strengthening local oversight over CPS performance with local prosecutors working up joint PCC / CPS prosecution priorities and, in time, fully devolving probation services to PCCs and directly elected mayors

### [Growing Up Digital Taskforce Report](#) – 4<sup>th</sup> January 2017

Children's Commissioner report sets out the case for a step change in how we prepare children for digital life and calling for the creation of a digital citizenship programme to be compulsory in every school from 4 to 14; simplified terms and conditions for digital services offered to children and a new Children's Digital Ombudsman

### [More major retailers join scheme to help prevent sales of knives to under-18s](#) – 22<sup>nd</sup> December 2016

Boots UK, the Co-op, B&Q and Aldi have joined the list of major retailers that have committed to the [voluntary agreement](#) to ensure knives are packaged and displayed securely and not sold or delivered to people under 18

## 2. Research, Development and Statistics

### [Police officer retention in England and Wales](#) – 3<sup>rd</sup> January 2017

Institute of Fiscal Studies analysis of police officer labour market between 2004 and 2015 highlights that as exit rates have changed little over time, Police force numbers have been largely driven by changing entry rates. The primary exit route for police officers was through ordinary retirement (62%), while 7% took early retirement on the grounds of ill health and 27% were voluntary resignations. Of the third that leave the police and continue in employment, only 15% continue in protective services or elementary security occupations, with the majority going on to occupations not directly related to policing. Areas with higher wages and lower unemployment rates are statistically significantly associated with higher resignation rates. There was no evidence to suggest that variation in crime rates and workload affect exit from the police service

### [Psychoactive substances ban 6 months on](#) – 29<sup>th</sup> December 2016

Home Office update six months after the [Psychoactive Substances Act](#) came into force (26<sup>th</sup> May 2016) notes that almost 500 people have been arrested for offences under the Act, 332 shops have been stopped from selling the Psychoactive substances and 31 headshops have been closed down. 4 people have been imprisoned for offences under the Act with other cases progressing through the criminal justice system

### [Child sexual exploitation: support in children's homes](#) – 21<sup>st</sup> December 2016

Department for Education rapid review of the international evidence on CSE support provided to children placed in residential care who have experienced, or are at risk of, child sexual exploitation. The review highlights the benefits of more guidance on what children's homes can legally do to prevent children from running away and good interagency work to underpin efforts such as Joint protocols and information sharing on missing children and identifying and prosecuting CSE perpetrators. The study concludes that while awareness of CSE and the body of evidence available is increasing, more robust evidence is required to know what interventions work best in reducing the prevalence of CSE, increasing children's resilience to it and helping children to recover

### [Stop and Search and knife crime](#) – 20<sup>th</sup> December 2016

Police Foundation blog examining the relationship between reasons for stops and searches and reasons for arrests suggests that there may be a potential link between falling numbers of stops and searches for drugs and rising knife crime. It also argues that stop and search may not be an efficient or effective way of 'taking knives off the streets' and that policing can only ever be one small part of a much larger task

### [Government Response to the Transforming Rehabilitation Inquiry Report](#) – 19<sup>th</sup> December 2016

Government response to the Public Accounts Committee [report](#) published September 2016 commits to:- completing commercial negotiations with CRCs and reviewing the payment mechanism as part of the comprehensive review into probation services by May 2017; Identifying issues with supervision of short-term prisoners and setting out how they will be tackled by summer 2017; Improving usability of nDelius and implementing a fully functional and reliable link between NOMS and CRC systems by Summer 2017 and; updating the Committee on progress by December 2017. The response also notes that the Department has put in place a full Data Governance and Assurance Framework for CRC and NPS data, collated examples of good practice through a series of nine regional workshops and started work with Clinks to get a better perspective on the views and needs of the Voluntary, Community and Social Enterprise (VCSE) organisations working with offenders. The first set of adult proven reoffending statistics under the new arrangements in autumn 2017

### [Government Response to the Antisemitism Inquiry Report](#) – 12<sup>th</sup> December 2016

Government response to the Home Affairs Committee [report](#) published October 2016 broadly accepts the IHRA definition of Antisemitism with some clarifications and makes commitments to ensure the CPS consider the words 'Zionist' or 'Zio' for inclusion as part of its current guidance for prosecutors. The response notes that advice is also being provided to individual police areas as part of the commitment to provide disaggregated data for all religious hate crime data within the Annual Data Requirement for police

## 5. Legislation

### **[Policing and Crime Bill](#) – Ping Pong Stage – 10<sup>th</sup> January 2017**

[Supporting documents](#)

- Places a statutory duty on police, fire and ambulance services to collaborate to improve efficiency and effectiveness. Enable PCCs to take on responsibility for fire and rescue services.
- Reforms the police complaints and disciplinary systems, including measures to extend disciplinary procedures to former officers (up to 12 months after leaving). Makes changes to governance of the IPCC.
- Enable chief officers to confer a wider range of policing powers on police civilian staff and volunteers.
- Introduces provisions in respect of breach of pre-charge bail conditions and makes changes to rules governing how police deal with people suffering mental crisis under s135 & s136 of Mental Health Act 1983
- Makes changes to terms of office for Deputy PCCs and would give the Home Secretary the power to change the name of a police area by order
- Provides statutory definition of the terms 'lethal', 'component part' and 'antique firearm' (Firearms Act 1968)
- Amends Licensing Act 2003 to make clear powdered and vaporised alcohol are both covered by the Act
- Makes provisions relating to the enforcement of EU, UN and other financial sanctions
- Mandates that offences relating to CSE (Sexual Offences Act 2003) cover streaming / transmission of indecent images of children. Enables Secretary of State to issue statutory guidance to local taxi and private hire licensing authorities with regard to the protection of children and vulnerable adults

### **[Children and Social Work Bill](#) – Committee Stage in Commons – 10<sup>th</sup> January 2017**

Bill to make provision about looked after children; ensure lessons are learned from serious child safeguarding cases; create a new 'power to innovate' giving local authorities the freedom to test out innovative new ways of working and introduce measures to improve how agencies share information;

### **[Digital Economy Bill](#) – Committee Stage in Lords – TBC**

Bill to make provision about; restricting access to online pornography; protecting intellectual property related to electronic communications; [improving government data to transform public services](#) - allow public authorities to share personal data with other public authorities to improve the welfare of individuals (e.g. Troubled Families programme), measures to help detect and prevent government losses due to fraudulent activity, The Bill also proposes tougher penalties for nuisance callers and increasing the sentencing options for people who infringe copyright laws online. ### **[Modern Slavery \(Transparency in Supply Chains\) Bill](#) – 2<sup>nd</sup> reading in Commons – 13<sup>th</sup> January 2017**

Private Members' Bill to require commercial organisations and public bodies to include a statement on slavery and human trafficking in their annual report and accounts; and to require contracting authorities to exclude from procurement procedures economic operators who have not provided such a statement. ### **[National Citizen Service Bill](#) – 2<sup>nd</sup> reading in Commons – 16<sup>th</sup> January 2017**

[NCS](#) brings different communities together and gives 15 to 17-year-olds the opportunity to take part in new experiences, develop skills and give back to communities across England. The Government has committed to offer an NCS place to everyone that wants one. [Lords briefing](#)

### **[Asset Freezing \(Compensation\) Bill](#) – 2<sup>nd</sup> reading in Commons – 20<sup>th</sup> January 2017**

A Bill to make provision for the imposing of restrictions on assets owned by persons involved in supplying terrorist organisations in the United Kingdom with arms, for the purpose of securing compensation for citizens of the United Kingdom affected by the supply of such arms.

## **Criminal Finances Bill – Commons Report Stage – TBC**

Tackle corruption, money laundering and tax evasion. Allow the Government to recoup more criminal assets by reforming the law on proceeds of crime, including provisions to strengthen our enforcement powers and protect the public. Introduction of a criminal offence for corporations who fail to stop their staff facilitating tax evasion; Improve the operation of the Suspicious Activity Reports (SARs) regime to encourage better use of public and private sector resources against the highest threats; to target entities that carry out money laundering instead of individual transactions; and to provide the National Crime Agency (NCA) with new powers; Improve the ability of law enforcement agencies and courts to recover criminal assets more effectively, particularly in cases such as those linked to grand corruption. ## **Homelessness Reduction Bill – Commons Committee Stage – 11<sup>th</sup> January 2017**

Private Members Bill to place a duty on local authorities to help eligible people at risk of homelessness to secure accommodation, 56 days before they are threatened with homelessness, and to provide those who find themselves homeless with support for a further period of 56 days to help to secure accommodation. The bill will also ensure that other local services refer those either homeless or at risk of being homeless to local authority housing teams. Bill builds on the government's commitment in December 2015 to consider all options, including legislation, to prevent homelessness. The draft bill underwent scrutiny by the Communities and Local Government Select Committee and has received [government support](#) [Commons briefing](#) - 24<sup>th</sup> Oct 2016

## **Preventing & Combating Violence Against Women & DV Bill - Commons Committee Stage – TBC**

Private Members' Bill to require UK to ratify the Council of Europe Convention on preventing and combating violence against women and domestic violence (the Istanbul Convention)

## **Sexual Offences (Pardons Etc.) Bill – Commons 2<sup>nd</sup> reading – 20<sup>th</sup> January 2016**

Private Members' Bill to formally pardon gay and bisexual men convicted for now abolished sexual offences and enable any mention of these offences to be removed from criminal record checks.

## **Stalking (Sentencing) Bill - Commons 2<sup>nd</sup> reading – 20<sup>th</sup> January 2017**

Private Member's Bill to increase the maximum sentences available to the court for stalking offences

## **Road Traffic Offenders (Surrender of Driving Licences) Bill - Commons 2<sup>nd</sup> reading – 27<sup>th</sup> January 2017**

Private Members' Bill to make provision about the surrender / production of driving licences or test certificates in relation to certain offences; and identifying persons / securing payment in connection with fixed penalty notices

## **Counter-Terrorism and Security Act 2015 (Amendment) Bill - Commons 2<sup>nd</sup> reading – 27<sup>th</sup> January 2017**

Private Members' Bill to repeal CT and Security Act 2015 provisions requiring teachers, carers and responsible adults to report signs of extremism or radicalisation amongst children in pre-school educational settings

## **Unlawful Killing (Recovery of Remains) Bill - Commons 2<sup>nd</sup> reading – 3<sup>rd</sup> February 2017**

Private Members' Bill to remove eligibility for parole, create a separate offence and make provision about available sentences in cases where a person, convicted of unlawfully killing another person, has not provided relevant knowledge in their possession for the purposes locating and recovering the remains

## **British Victims of Terrorism (Asset-Freezing & Compensation) Bill - 2<sup>nd</sup> reading – 24<sup>th</sup> February 2017**

Private Members' Bill to make provision about the freezing and seizing of assets belonging to states or organisations who sponsor or perpetrate acts of terrorism for the purposes of enabling compensation to be paid

## **Malicious Communications (Social Media) Bill - Commons 2<sup>nd</sup> reading – 24<sup>th</sup> March 2017**

Private Members' Bill to make provision about offences, penalties and sentences in relation to communications containing threats transmitted or broadcast using online social media
