1. POLICY AND PRACTICE

Lord Ferrers Awards for Volunteers in Policing opens for nominations - 5 June 2019

The awards recognise exceptional volunteer dedication across 10 individual and team categories including Special Constabulary, Police Support Volunteer, Volunteer Police Cadet, Employer Supported Policing Award, Leadership Award, Technical Innovation Award and OPCC Volunteer. Deadline for nominations is 15 July 2019

Apply for funding: Youth Endowment Fund - 28 May 2019

The £200m Youth Endowment Fund opens for bids to support programmes and community partnerships working with children (aged 10 to 14) at risk of being drawn into crime and violence. Bidding is open to charities and social enterprises, for-profit organisations and public sector agencies including schools, local authorities and police. Applicants can apply for up to two years of funding, and must be in a position to use the first £100,000 of funding between October 2019 and March 2020. The deadline for bids is 23 July 2019.

New national strategy to tackle Gypsy, Roma and Traveller inequalities - 6 June 2019

Communities Minister launches national strategy to tackle entrenched inequality and improve the lives of Gypsy, Roma and Traveller communities. The strategy complements £200,000 funding made available for 6 projects aiming to improve educational attainment, health and social integration outcomes for Gypsy, Roma and Traveller communities, 22 projects funded through the Controlling Migration Fund and 2 projects aiming to improve the reporting of hate crime by Gypsy, Roma and Traveller communities.

Indicators of Integration framework launched - 3 June 2019

Immigration Minister launches a new Home Office resource for local authorities, charities and those working with groups at risk of poor integration. The framework provides practical ways to understand and measure the integration of refugees and migrants.

<u>Justice Minister keynote speech – Modernising Criminal Justice Conference</u> – 11 June 2019

Minister calls for a 'whole system approach' to criminal justice reform to "turn the tide on reoffending, with safe, secure and modern rehabilitative prisons, effective alternatives in the community for the punishment and treatment of offenders and the protection of the public – 'it is clear that short prison sentences simply aren't working' - probation services that are stronger and see more investment in skilled staff and innovation, and greater use of new technology, such as GPS tags and video conference centres in jails.

New anti-knife crime school lessons - 5 June 2019

Home Office and the Personal, Social, Health and Economic Association issue PSHE teachers with new hourlong lesson plans for children aged between 11 and 16. The plans aim to confront the myths realities of carrying a knife and include real-life case studies of young people from the latest #knifefree campaign along with new content on the importance of having good role models. The plans follow a series of lessons on knife possession introduced in 2018.

Ministry of Justice Victim and Witness funding 2019/20 - Published 5 June 2019

Ministry of Justice publishes details of grant funding awarded to PCCs and nationally commissioned service providers from the Victim and Witness Budget to deliver victim and witness support.

Strengthening probation, building confidence engagement events - Ongoing updates

A range of sessions have been scheduled in London, Cardiff, Manchester and York throughout June, July and August in addition to webinars being held on 25th June and 22nd July 2019.

A guide to using artificial intelligence in the public sector - 10 June 2019

Government Digital Service and the Office for Artificial Intelligence publish joint guidance on how to build and use artificial intelligence (AI) in the public sector, including how to assess whether it will help meet user needs and how to implement AI ethically, fairly and safely. The Minister for Implementation also launched an online marketplace to support tech start-ups sell to the public sector.

2. RESEARCH, DEVELOPMENT AND STATISTICS

The Use of Algorithms in the Criminal Justice System - 4 June 2019

Law Society publishes findings of the Technology and Law Public Policy Commission's review of the use of algorithms in the CJS. The report concludes that while algorithms have the potential to deliver significant benefits to individuals and communities – this should not be taken for granted. An uncritical reliance on technology could lead to wrong decisions that threaten human rights and undermine public trust in the justice system. The report makes recommendations which include strengthening oversight, strengthening algorithmic protections in data protection, ethical and transparent procurement, clarity of the lawful basis of algorithmic systems in the criminal justice system and significant investment in analytical capacity and capability to support public bodies in understanding the appropriateness of algorithmic systems and how to deploy them responsibly.

Ending the inertia for women offenders: a plan to transform outcomes - 6 June 2019

Crest Advisory report highlights the lack of progress in delivering improvements in outcomes for female offenders and sets out a blueprint for how PCCs, prisons, probation, health services, police and charities can remove barriers to change for women offenders. The report makes a range of recommendations including:-

- Piloting diversion pathways in courts to identify women in need of intervention
- Exploring new requirements for courts to attach financial planning support as a condition of sentence
- Establishing retail-based diversion schemes and trialling new rehabilitative out of court disposals for women
- Developing a better understanding of women entering the criminal justice system via non-policing routes
- Developing vulnerable women's strategy involving criminal justice and other agencies
- · Commission analysis of where local women are in prison to understand how it will be impacting on family life
- Ensure pre-sentence reports provide information about women's needs and offending circumstances
- Devolve custody budgets for women to PCCs and mayors to increase investment in community provision
- Develop alternatives to short custodial sentences and make greater use of electronic tagging
- Comprehensively review current local gender-specific provision to ensure they have a full picture
- Develop gender-informed probation services which stress the importance of support to women offenders

Intervening with women offenders (CARE Programme) - 6 June 2019

Process and interim outcome study of the Choices, Actions, Relationships and Emotions programme for medium to high risk female prisoners which has been delivered in 2 custodial sites; HMP Foston Hall since 2011 and HMP New Hall since 2014. This study uses quantitative and qualitative methods to gauge the short-term effectiveness of CARE and to gain insight into participant and staff perceptions of the programme.

Exploring the nature of muslim groups and related gang activity in prison - 6 June 2019

Findings from qualitative research in 3 high security prisons. The study found the main prisoner group to be a large, diverse group of prisoners who connected through a shared Muslim faith. Membership offered many supportive benefits including friendship, support and religious familiarity. Violence, bullying and intimidation were prevalent with the gang, using religion as an excuse to victimise others. The gang was perceived to be responsible for the circulation of the majority of the contraband goods in the establishments. The report discusses how the findings can be used to inform management approaches, such as ensuring systems are in place to identify and support prisoners who are particularly vulnerable, improve staff training and education, and the use of culturally matched mentors and external experts.

Women as Protectors: Outcomes Evaluation – 12 June 2019

NSPCC report capturing learning from programme of work to help mothers protect children from sexual abuse concludes that the programme is effective at placing women in a stronger position to provide a safe environment for their children and mitigate the risk posed by an unsafe man. Women's mental and emotional wellbeing improved during the programme and they gained confidence in their parenting ability. They reported greater knowledge and understanding about sexual abuse and felt better able to talk to their children about it. Women also felt empowered to make decisions about the unsafe men in their lives.

ACMD report: Custody-community transitions - 12 June 2019

Advisory Council on the Misuse of Drugs report on reducing drug-related harms that occur when people move between custody and the community highlights a lack of systematic follow-up on and the fragmentation of responsibility for implementing previous recommendations. Previous reports had highlighted continuity of care as being critical, however, latest PHE data suggests that only 32.1% of people assessed as needing treatment when they leave prison enter treatment in the community within 21 days of release. The report recommends:

- minimising the use of sentences of less than 12 months, with the aim of eliminating the use in sentencing of periods of less than 3 months in prison; and reforming the system of supervision on licence to reduce recalls
- Ensure prison services minimise the release of prisoners with complex needs on Friday afternoons
- DWP to accelerate the introduction of the measures listed in the Rough Sleeping Strategy to enable
 prisoners to access employment or Universal Credit immediately on release and work with the courts and
 Probation Service to ensure people imprisoned are not overpaid the housing element of Universal Credit
- Prison and probation services develop and extend services that provide face-to-face, individualised support to prisoners who have drug problems in the run up to release and through the transition to the community.

Operation of police powers under the Terrorism Act 2000 to March 2019 - Published 13 June 2019

Home Office statistics highlight a 40% decrease in arrests for terrorism-related activity in in 2018/19 (268) compared to the previous year (443), with levels returning to the pre-2017 average. Of the arrests recorded in 2018/19, 90 (34%) resulted in a charge - of which 70 were charged with terrorism-related offences, 69 (26%) were released without charge and 93 (35%) were either released under bail pending further investigation, or released under investigation. Of the 70 persons charged with a terrorism-related offence, 32 had been prosecuted, all of whom had been convicted. A total of 34 people were awaiting prosecution, one was not proceeded against and three received other outcomes. Falls in the number of arrests were seen across all ethnic groups, but were most pronounced among people from Asian backgrounds. Consequently, the proportion of arrestees who were Asian (36%) fell to a lower level than those who were White (41%). As at 31 March 2019, there were 223 persons in custody in Great Britain for terrorism-related offences, a decrease of 2% on the previous year and marking the first fall since 2012/13.

Knife and offensive weapon sentencing statistics to March 2019 - Published 13 June 2019

Ministry of Justice statistics highlight a 34% increase in knife and offensive weapon offences formally dealt with by the CJS between 2014/15 (16,438) and 2018/19 (22,041), reaching the highest level recorded since March 2010 (23,667). The proportion of weapon offences resulting in an immediate custodial sentence has risen from 22% to 37% over the last decade, while average sentences rose from 5.5 months to 8.1. The proportion of offenders for whom this is their first possession offence has fallen to 72% - the lowest level since comparable records began in 2009 (80%). Data available at police force level

Details of Criminal legal aid review confirmed - 13 June 2019

Ministry of Justice review will consider criminal legal aid throughout the life cycle of a criminal case, including:

- pre-charge advice at police station, advice in Magistrates' & Youth Court and advice and for prisoners
- advice and litigation services in the Crown Court, including for very high cost Crown Court cases

The review will also consider wider changes to the justice, social, economic, business and technological landscape that are impacting on the criminal legal aid system – including HMCTS reform, the Attorney General's review of disclosure, and wider modernisation work being pursued by the Home Office and police.

Victims of Crime (Rights, Entitlements, Notification of CSA) Bill - Lords 2nd reading - TBA

Private Members' Bill to make provision for specifying new statutory rights and entitlements for victims of crime under the Victims Code of Practice; require PCCs to assess victims services; increase duties of the Victims and Witnesses Commissioner; grant victims the right to request a review of a decision not to prosecute

Road Traffic Offenders (Surrender Driving Licences) Bill - Lords 2nd reading - TBA

Private Members' Bill to make provision about the provision and surrender of driving licences or certificates in relation to certain offences; make provision in relation to identifying persons in connection with FPNs etc.

Modern Slavery (Transparency in Supply Chains) Bill - Lords 2nd reading - TBA

Private Members' Bill to make further provision for transparency in supply chains in respect of slavery and human trafficking

Parental Rights (Rapists) and Family Courts Bill - Commons 2nd reading - TBA

Private Members' Bill to remove the parental rights of fathers of children conceived through rape; to make provision for an inquiry into the handling by family courts of domestic abuse and violence against women and girls in child arrangement cases.

Police Officer Training (Autism Awareness) Bill - Commons 2nd reading - TBA

Unauthorised Encampments Bill - Commons 2nd reading - TBA

- <u>Draft Domestic Abuse Bill</u> to provide for a statutory definition of domestic abuse, establish the office of Domestic Abuse Commissioner; provide for a new Domestic Abuse Protection Notice and Domestic Abuse Protection Order; prohibit perpetrators of domestic and other forms of abuse from cross-examining their victims in person in the family courts; create a statutory presumption that complainants of an offence involving behaviour that amounts to domestic abuse are eligible for special measures in the criminal courts; enable domestic abuse offenders to be subject to polygraph testing as a condition of their licence; place Domestic Violence Disclosure Scheme guidance on a statutory footing; ensure local authorities grant secure lifetime tenancies for social tenant, where reason is in connection with domestic abuse.
- <u>Draft Drones Bill</u> introducing new police powers to issue fixed penalty notices for minor drone offences, request evidence from drone users where there is reasonable suspicion of an offence being committed and to land, seize and search drones. Require registration and competency testing for drone use
- <u>Draft Mental Health Bill</u> to transform mental health care, allow those detained under the MH Act to be allowed to nominate a person of their choice to be involved in decisions about their care. Enable people to express preference for care and treatment and have these listed in statutory 'advance choice' documents
