1. POLICY AND PRACTICE

Apply for funding: £1.5m Anti-Knife Crime Community Fund - 26 June 2019

Home Office launches third round of Anti-Knife Crime Community Funding for community projects delivered by voluntary sector organisations to respond to the challenges around knife crime, and in particular support activities to preventing young people from engaging in knife related offending. The Home Office welcomes bids for single projects of up to a maximum of £30,000 from organisations with previous proven history of delivering anti-knife crime work. The deadline for applications is 24 July 2019.

Apply for funding: Youth Endowment Fund – 28 May 2019

The £200m Youth Endowment Fund opens for bids to support programmes and community partnerships working with children (aged 10 to 14) at risk of being drawn into crime and violence. Bidding is open to charities and social enterprises, for-profit organisations and public sector agencies including schools, local authorities and police. Applicants can apply for up to two years of funding, and must be in a position to use the first £100,000 of funding between October 2019 and March 2020. The deadline for bids is 23 July 2019.

Home Office allocates £35m to police forces for violence reduction units - 18 June 2019

Home Office provisionally allocates £35m to PCCs in 18 local areas to develop violence reduction units as part of a multi-agency approach. The units will bring together police, local government, health, community leaders and other key partners to identify the drivers of serious violence locally and develop a coordinated response to tackle them. The 18 areas will set out plans demonstrating how they will use their provisional allocation to build a public health approach delivering both short and long-term action ahead of being awarded the funding. The investment comes from the £100m serious violence fund announced by the government in March 2019.

Recipients of Early Intervention Youth Fund 2019/20 announced - 26 June 2019

Home Secretary announces further recipients of £22m Early Intervention Youth Fund to support projects that steer young people away from knife crime and serious violence and help them make more positive life choices.

Open for nominations: Lord Ferrers Awards for Volunteers in Policing – 5 June 2019

The awards recognise exceptional volunteer dedication across 10 individual and team categories including Special Constabulary, Police Support Volunteer, Volunteer Police Cadet, Employer Supported Policing Award, Leadership Award, Technical Innovation Award and OPCC Volunteer. Deadline for nominations is 15 July 2019

Further roll out of 'Lifeline' community treatment (CSTR) pilots - 21 June 2019

Ministry of Justice announces plans for roll out of Community Sentence Treatment pilots across 9 further courts in in London and Greater Manchester. This pilot sees justice and health services coming together to deliver tailored rehabilitation at the point of sentencing. Specialist staff assess offenders whose crime makes them eligible for a Community Order, while Probation and healthcare staff ensure Magistrates and Judges have the information they need to determine whether the offender should receive treatment for their mental health, alcohol or drug issues – each issue affects approximately one third of assessed offenders. The launch of the pilot last summer has resulted in a significant 250% increase in the number of offenders being diverted towards mental health treatment programmes in the community, over an 18-month period. 80% of CSTRs were sentenced on the day, while only 8% of offenders who received a CSTR failed to comply with their requirements

Government response to consultation on Firearms Licensing Fees – 18 June 2019

Government response <u>confirms</u> plans to introduce fees on specialist (Section 5) firearms licences, which includes some of the most dangerous types of guns, such a military grade weapons. Current licence holders include organisations such as manufacturers or dealers supplying the police or the army, and individuals such as gunsmiths carrying out the deactivation of prohibited weapons. Fees are already payable for certificates to possess civilian firearms, such as rifles for target shooting or shotguns, commonly used for pest control.

Home Office and Ministry of Justice Single Departmental Plans- Updated 27 June 2019

Government publishes departmental plans setting out objectives, how they will be achieved and measured, and details of departmental budget and workforce.

Victim Surcharge circular - 25 June 2019

Ministry of Justice circular detailing changes to the levels of Victims Surcharge imposed on offenders via the Criminal Justice Act 2003. The surcharge, which is applicable to all court sentences and varies based on sentence severity, will increase in-line with expected inflation for 2019/20 – 2020/21 by a maximum of £11. Changes take effect on offences committed on or after 28 June 2019.

2. RESEARCH, DEVELOPMENT AND STATISTICS

Testing the effectiveness of initiatives to reduce serious violence and vulnerability - 18 June 2019

College of Policing Vulnerability and Violent Crime Programme publishes details of eight promising policing initiatives that are being independently evaluated in order to help develop the evidence on their effectiveness in reducing vulnerability and serious violence. These include the Metropolitan Police Service's DIVERT intervention and Operation Divan, the Think Family Early Intervention programme and Surrey Police's High Harm Perpetrator Unit. All eight evaluations are scheduled for completion in March 2020

ACMD report: drug-related harms in homeless populations – 19 June 2019

ACMD report explores the risk factors which make homeless people susceptible to substance misuse-related harms. The report concludes that the needs of people who are homeless, particularly rough sleepers, are not well met by mainstream benefits, health and social care and some drug services and highlights the necessity to address housing needs alongside drug treatment needs. The personal safety risk among people who use drugs and are experiencing homelessness is generally significantly higher, as are rates of serious bacterial infections, HIV and hepatitis C. Recommendations of the report include:-

- Enabling local services to adopt a tailored approach to tackling the specific needs of homeless drug users
- Substance, mental health and homelessness services adopting evidence-based approaches to tackling drug misuse and engaging and retaining people in treatment (e.g. integrated services, outreach, peer mentors)
- Raising awareness among service providers of the levels of stigma experienced by homeless individuals who use drugs and ensure they are treated with respect
- Involving people with experience of homelessness and substance use in the design and delivery of the service provision for substance use and homelessness services

Healthcare for Offenders: CSTR Protocol Process Evaluation - published 20 June 2019

Process evaluation to understand the mental health and substance misuse needs of offenders, and whether existing health arrangements accommodate for these needs; understand any barriers to an individual being given a Community Sentence Treatment Requirements (CSTR), and if so, what these are and; to find out whether the protocol works and whether changes are needed ahead of any further roll out

In Ten Years Time - 19 June 2019

Revolving Doors Agency and Centre for Mental Health publish report on improving outcomes for people with mental ill-health, learning disability, developmental disorders or neuro-diverse conditions in the criminal justice system. The report argues that too many people with these conditions are being sent to prison despite and highlights a 29% fall in pre-sentence reports completed from July-September 2013 to July-September 2018.

Best practice in the management of online sex offending - Published 21 June 2019

University of Plymouth publishes findings from secondary research exploring best practice in the management and prevention of online child sexual exploitation. Recommendations include promoting public engagement, introducing earlier intervention methods, developing international agreements and developing programmes of prevention-focused research.

World Drug Report 2019 – 27 June 2019

The United Nations Office on Drugs and Crime's World Drug Report 2019 finds that global illicit cocaine production reached a record high in 2017, marking a 25% increase on the previous year. The global quantity of cocaine seized increased by 13% during the year to the largest quantity ever reported.

Violence reduction in prison – Published 17 June 2019

HM Prisons and Probation Service publishes a summary of evidence about what works and doesn't work, to help reduce violence in prison. NPCC publishes Crime in Prison Referral Agreement

Firearm certificates in England and Wales statistics 2018/19 - Published 27 June 2019

159,745 firearm certificates were on issue, continuing the steady year-on-year increase seen over the past 9 years. 572,488 shotgun certificates were on issue, with little variation in numbers over the last 10 years. Data available at <u>police force level</u>.

Legal aid statistics January to March 2019 - Published 27 June 2019

Ministry of Justice statistics show that police station advice workload increased by 2% during January to March 2019 while magistrates' court expenditure fell by 7% compared to the same quarter last year.

Criminal court statistics: January to March 2019 - Published

Ministry of Justice statistics show continued reductions in Magistrates court receipts and disposals. Outstanding crown court cases and average (median) waiting times have fallen to the lowest level since comparable records began. The mean number of days from first listing in the magistrates' court to completion in the Crown Court (178 days) remains broadly stable. Data available LCJB level

3. AUDITS AND INSPECTIONS

HMICFRS Fire and Rescue Service inspections 2018/19 (tranche 2) - 20 June 2019

Findings from 16 fire and rescue services inspected as part of the second tranche of national inspections finds that while most fire and rescue services showed strengths in the way they prepared for and responded to fires and other emergencies, localism has led to marked differences in how services determine and record their response standards, identify and mitigate risk; and define and audit high-risk premises. The report warns that some services have faced significant funding reductions, with Northamptonshire and Northumberland in particular being unlikely to absorb any further reductions without adversely affecting their service. In terms of effectiveness and efficiency, 9 of the 16 Fire and rescue services inspected were assessed as 'good', while 7 'require improvement'. 4. REVIEWS AND INQUIRIES

Victims' Commissioner Annual Report 2018/19 - Published 27 June 2019

Baroness Newlove's final Annual Report considers progress on objectives to date and details of budget and spending. The outgoing commissioner urges reform in culture of criminal justice system. And reiterates calls for victims to be given statutory rights to be informed, be heard and to challenge.

Tackling serious and organised crime - 28 June 2019

National Audit Office report examining the government's strategic response to serious and organised crime notes that serious and organised criminality is evolving at a rapid rate, adapting in response to law enforcement action and the opportunities offered by new technology. Those tackling serious and organised crime recognise the seriousness of this challenge and have plans in place to build the teams and expertise to deal with it. The report concludes, highlights, however that the government and NCA are not yet able to show that they are delivering value for money in this area, do not know whether their efforts are working and are not yet able to target resources against the highest-priority threats. Despite ongoing efforts to improve them, governance and funding arrangements remain complex, inefficient and uncertain. The report states that unless the government addresses these issues there will continue to be a mismatch between its ambitious plans to respond to serious and organised crime and its ability to deliver on them. Importance of strengthening female offenders' family and other relationships - 18 June 2019

Lord Farmer's second review considers the importance of strengthening female offenders' family and other relational ties across both custody and the community as a key factor for rehabilitation and reducing intergenerational crime. The review found that at least 54% of women in prison have children under the age of 18 and only 5% of children remain in the family home when their mother is sent to prison. Prisoners who receive family visits, meanwhile, are 39% less likely to reoffend, with research suggesting that these relationships are even more important for women than they are for men. The review makes a wide range of recommendations which the Ministry of Justice has committed to taking forward, including each prison having an on-site social worker to provide dedicated support for women and their children and greater use of Release on Temporary Licence to help female offenders fulfil their caring responsibilities and aid resettlement. The review also recommends a 'Personal Circumstances File' for each offender to ensure information on dependents is readily available and carried throughout their journey through the criminal justice system.

Review of non-consensual taking, making and sharing of sexual images - 26 June 2019

MoJ announces Law Commission review of the non-consensual taking, making and sharing of sexual images under plans to ensure that protections keep pace with emerging technology. The review will consider a range of digital trends such as 'cyber-flashing' and 'deepfake' pornography and consider the case for granting automatic anonymity to victims of 'revenge porn'. The review is scheduled to report back in the summer of 2021.

- <u>Draft Domestic Abuse Bill</u> to provide for a statutory definition of domestic abuse, establish the office of Domestic Abuse Commissioner; provide for a new Domestic Abuse Protection Notice and Domestic Abuse Protection Order; prohibit perpetrators of domestic and other forms of abuse from cross-examining their victims in person in the family courts; create a statutory presumption that complainants of an offence involving behaviour that amounts to domestic abuse are eligible for special measures in the criminal courts; enable domestic abuse offenders to be subject to polygraph testing as a condition of their licence; place Domestic Violence Disclosure Scheme guidance on a statutory footing; ensure local authorities grant secure lifetime tenancies for social tenant, where reason is in connection with domestic abuse.
- <u>Draft Drones Bill</u> introducing new police powers to issue fixed penalty notices for minor drone offences, request evidence from drone users where there is reasonable suspicion of an offence being committed and to land, seize and search drones. Require registration and competency testing for drone use
- <u>Draft Mental Health Bill</u> to transform mental health care, allow those detained under the MH Act to be
 allowed to nominate a person of their choice to be involved in decisions about their care. Enable people to
 express preference for care and treatment and have these listed in statutory 'advance choice' documents

Sentencing Council consultation on draft guideline on sentencing offenders with mental health conditions or disorders, including principles that courts should focus on individual circumstances and decide how much responsibility the offender retains for the offence, given the specific facts of the case.

Home Office call for evidence to inform a review of the Fire Safety Order which regulates fire safety in non-domestic premises which is due to be updated.
