**[Police and crime commissioners hail College work on integrity](#)** - On the first anniversary of the election of police and crime commissioners, police commissioners on the Board of the College of Policing have hailed the work of the College in helping to build confidence in policing.

In 2015/16, a fund of £14m will be made available, though the press release doesn't state how much of that will be distributed to PCCs.

There has been a 28% drop in police referrals to the CPS on child sex abuse cases in the past two years. In 2012/13 a reported sexual offence against a child was 24% less likely to be passed from the police to the CPS than in 2010/11.

[ALERT - Mass ransomware spamming event targeting UK computer users](#) - The NCA's National Cyber Crime Unit are aware of a mass email spamming event that is ongoing, where people are receiving emails that appear to be from banks and other financial institutions. The emails may be sent out to tens of millions of UK customers, but appear to be targeting small and medium businesses in particular. This spamming event is assessed as a significant risk. The emails carry an attachment that appears to be correspondence linked to the email message (for example, a voicemail, fax, details of a suspicious transaction or invoices for payment). This file is in fact a malware that can install Cryptolocker – which is a piece of ransomware. Cryptolocker works by encrypting the user's files on the infected machine and the local network it is attached to.

## **3. Reviews and Inspections**

### **[HMIC: Freeing Up Police Time](#)**

Following a review of the progress made with the issues raised in HMIC's 2010 report [Stop the Drift](#)<sup>1</sup>, HMIC intends to scope an inspection to identify what else might be done to reduce unnecessary burdens on forces. This will include (but not necessarily be limited to) an

examination of how police efficiency and working practices should be improved through the use of modern technology. The on site inspection will take place on 2-5 December 2013.

## **HMIC: Value for Money Profiles**

Profiles for forces and local policing bodies to assist in making budget decisions.

**HMIC Published: Working Together**. A review of the arrangements for collaboration between the five East Midlands police forces, commissioned by the police and crime commissioners in the region has been published.

**Her Majesty's Inspector of Probation**: Published Victim Contact: An inspection of the Victim Contact Arrangements in Probation Trusts.

**HMIC published findings from an inspection of South Yorkshire Police's response to child sexual exploitation**. This inspection was commissioned by the PCC for South Yorkshire.

## **Her Majesty's Inspectorate of Constabulary's (HMIC) approach to monitoring forces – An overview for the public, forces and local policing bodies**

Her Majesty's Inspectors of Constabulary (HMIs) routinely monitor the performance of all police forces to identify apparent issues for closer scrutiny, ensure emerging problems with efficiency and effectiveness are spotted quickly, and problems are resolved quickly with Chief Constables and local policing bodies.

**HMIC: Domestic Violence**: On 9 September, the Home Secretary commissioned HMIC to look at the effectiveness of the police response to cases of domestic violence and abuse. Started for Nottinghamshire on the 4 November. This is a Home Secretary commissioned Thematic due to be completed by April 2014.

**CJJI: Child Protection Arrangements**. In June 2013, the HMIC Board agreed a series of child sexual exploitation related inspections to be conducted over the next three years.

**HMIC: National Thematic Review – Automatic Number Plate Recognition (ANPR)**. The scope of the inspection is subject to further development but the focus in the prevention of crime.

## **CJJI: National, Thematic Review: Road Traffic Offences Involving Fatalities**

In the light of continuing concern about traffic offences involving fatalities, despite the introduction of new offences in 2008, the review will analyse and assess the quality of police/CPS investigation and prosecution of such cases, and the progress made by the CPS following HMCPSI's 2008 review, establish good practice and make recommendations for positive change. Inspection in 2013/14.

## **CJJI Inspection: Integrated Offender Management (IOM)**

IOM provides an overarching framework for agencies to prioritise interventions with offenders of greatest concern in their locality. This inspection is intended to assist in assessing the impact of IOM and disseminating good practice.

## **HMCPSPSI Inspection: Statutory Charging**

The previous joint report in 2008 highlighted a number of concerns over the efficiency of the operation of the statutory charging scheme (whereby the CPS took over the responsibility from the police for determining whether an alleged offender should be charged in the more serious or contested cases, by virtue of the Criminal Justice Act 2003). With changes in the landscape implemented in 2010–11 and 2012–13, this follow-up was postponed to 2013-14.

**HMIC: Crime Data Integrity.** This inspection will examine the effectiveness of the police in dealing with reports of crime by members of the public. The scope is subject to development but is likely to build on the findings of HMIC's previous inspections in this area. Scoping work will include consultation with the Crime Statistics Advisory Committee.

### [Nottingham tops East Midlands bedroom tax poll](#)

Nottingham has the most households in the East Midlands affected by the 'bedroom tax', it is claimed. Under Government changes to housing benefit, anyone who is deemed to be under-occupying their home by one bedroom loses 14 per cent of their housing benefit, and 25 per cent if they have two unused bedrooms. New data released by the Government and analysed by the National Housing Federation shows Nottingham has 5,288 households affected by the change – the most in the region. It also found tenants in Nottingham faced an average reduction in housing benefit of £701.72 per year.

## [College of Policing statement on integrity in policing](#)

The consultation on the draft code has been launched by the College of Policing, and runs for five weeks until November 29. The final code is expected to be published next spring. The Code of Ethics will set out the standards of behaviour expected of everyone in policing. It will apply to the more than 220,000 police officers and staff across England and Wales. It emphasises the importance of personal integrity, honesty and fairness.

## [Legislative Reform Order: Changes to entertainment licensing](#)

This consultation is about implementing reforms to entertainment licensing via a Legislative Reform Order. It sets out proposals to amend the [Licensing Act 2003](#) so that certain entertainment activities in defined circumstances no longer require a licence before they can take place. The consultation closes on 17 December 2013.

## **Government ministers have announced a public consultation to decide on pension scheme charges, expected to cap management fees charged by pension providers at around 0.75 per cent.**

The Financial Secretary to the Treasury, Sajid Javid MP, said the plans would ensure "someone's saving will deliver the biggest possible returns and not be eaten away at by a variety of charges and fees" ([F.T.](#); [Telegraph](#); [Times](#); [Mail](#); [Mirror](#); [BBC Online](#); [City A.M.](#)).

## [Ministry of Justice Consultation on Transforming Management of Young Offenders](#)

The Ministry of Justice (MoJ) has today launched a consultation into proposals on changes to the way young adult offenders are managed in custody and access support and services to reduce their reoffending. Consultation closes 13 December.
