This Order makes additional provision for the publication of details of candidates, and their election addresses, for election to the office of police and crime commissioner.

### [Local Government Independence Bill to be launched](#)

Graham Allen, Chair of the Political and Constitutional Reform Committee, has launched a new bill intended to overhaul the relationship between local and central government.

### [Government publishes guidance on responsibilities of bodies involved in surveillance](#)

The Surveillance Camera Commissioner and Information Commissioner's Office have published a "Surveillance road map" to clarify the roles and responsibilities of the bodies involved in overseeing surveillance legislation in the UK.

### [Missing persons law comes into force](#)

Following the implementation of remaining provisions of the Presumption of Death Act 2013, from 1 October 2014 a legal framework will exist for the creation of a presumption of death certificate scheme in England and Wales – bringing it in line with Scotland and Northern Ireland.

### [Derbyshire businesses receive £3m boost](#)

Businesses in Derbyshire will be able to bid for a share of £3m to generate jobs and to improve the local economy. Businesses in Derbyshire are to benefit from a £3m fund to assist small enterprises. The Derbyshire Economic Partnerships secured the money from the government’s Regional Growth Fund. The scheme is backed by Derbyshire County Council.

### [Councils save money by sharing ICT services](#)

Three councils have formed a new company to deliver ICT services. Strata Service Solutions Ltd will be wholly owned and controlled by Exeter City, Teignbridge District, and East Devon District Councils. A £2.2m investment will come from the three councils to set-up the company, with Exeter and East Devon fronting more money than Teignbridge.

West Sussex County Council has spent £20,000 developing a new performance dashboard that enables residents and journalists to access data that shows if key targets are being met. A new platform that enables residents and journalists monitor if key targets are being met has been implemented by West Sussex County Council.

Three councils are planning to form a recruitment agency to help deliver their children’s social care services through the provision of locum social workers.

### [Cutting public sector food waste through new buying standard](#)

From 2017, central government will commit to buying fresh, locally sourced, seasonal food, in an attempt to reduce waste through food reduction. Newly appointed environment secretary Elizabeth Truss revealed that this will be done through a new, simplified food and drink buying standard.

### [Public sector staff to be given training on FGM](#)

Teachers, doctors and social workers are to be given extra training to help identify and assist girls at risk of female genital mutilation (FGM).

### [MPs call for B&B ban for young care leavers](#)

Young adults leaving the care system in England should not be placed in bed and breakfasts (B&Bs), and should have the right to stay in care until they are 21, say MPs.

## [Councils must make roads safer for cyclists – Transport Select Committee](#)

The government should make it “easier and cheaper” for local authorities to bring in lower speed limits to reduce the number of cycling fatalities on the country’s roads, the Transport Select Committee has stated.

## [Spending cuts ‘disproportionately’ affecting northern councils](#)

Local authority budget cuts are ‘disproportionately’ affecting councils in the north of England and those in the most deprived areas. Research by the Sheffield Political Economy Research Institute (SPERI) revealed that councils in the North West have experienced an average reduction of £234.76 per person, followed by Yorkshire with £197.24 per person, and the North East with £189.16.

## [More flexibility for NHS doctors under European Working Time Directive](#)

Significant changes will be considered so doctors can train and work more flexibly, the Government announced. These changes will be explored in response to an independent review of the impact and implementation of the European Working Time Directive on the NHS and Health Professionals.

The third of [NHS Clinical Commissioning Groups](#) that were reported to have no plans to retender community services despite widespread expectation among public and independent sector providers that these contracts would come up for tender between now and April 2016.

An independent review of [Staff Engagement and Empowerment](#) in the NHS called for the “accelerated evolution” of alternative models of healthcare provider, including staff owned mutuals.

Data from the [Crime Survey of England and Wales](#) showed a record 14 per cent fall in crime in the last 12 months to reach the lowest level in 33 years.

This inspection examined how well police forces have established the arrangements that the Strategic Policing Requirement requires them to have in place to counter a number of specified threats to national security and public safety. It is based on data and documentary evidence provided by all 43 police forces in England and Wales in July 2013. It includes supporting fieldwork, conducted in 18 forces, and in nine Regional Organised Crime Units (ROCUs).
