## **2. Strategic policing and crime news**

### **[Crime and policing news update: September 2014](#)**

#### **[New agreement on closer working to improve public trust in policing](#)**

Three national policing oversight bodies have signed a concordat in relation to their promotion of good practice and continuous improvement in policing, in order to ensure public confidence. The working concordat has been agreed between Her Majesty's Inspectorate of Constabulary (HMIC), the Independent Police Complaints Commission (IPCC), and the College of Policing.

**Police Superintendents' Association conference.** The Home Secretary gave a [speech](#), explaining how reforms have given the police more powers so they can decide how best to tackle crime locally, whilst overall crime has fallen by 10%.

**Police reform was also the theme of the Home Secretary's speech to the Reform think tank**, where she set out the changes that have been introduced and areas still needing work. In her [speech](#), she also talked about the Home Office's work to identify the drivers of crime and develop policies to prevent crime occurring in the first place.

#### **[Police step up fight to stamp out child sexual exploitation](#)**

Police forces across England and Wales are raising their game in the battle to eradicate child sexual exploitation, the National Policing Lead for Child Protection has said. Chief Constable Simon Bailey told Crime Prevention Minister Norman Baker improvements were already being made following revelations of widespread child sexual abuse over many years in Rotherham.

Under this standard, major A&E departments in England will collect and share non-confidential data about attendances involving violent crime with Community Safety Partnerships.

## **[Worst austerity still to come, public sector warned](#)**

Public sector austerity is set to continue for another five years, outgoing civil service chief Sir Bob Kerslake has warned. Speaking at the Institute for Government last night, he said that while the last five years of cuts had been challenging 'the second five years are likely to prove even harder'. The former Sheffield City Council chief executive, who became head of the civil service in 2012, warned the 'easier' savings had already been made.

## **[Brake urges government action as figures confirm stalled progress in road casualty reduction](#)**

The government's official annual road casualty report, have confirmed figures showing disappointingly slow progress in reducing road casualties in the UK. 1,713 people were killed in 2013, at a rate of five a day, 2% fewer than in 2012. 21,657 people suffered serious injuries, at a rate of 59 a day, 6% fewer than in 2012. *Provisional figures were released in June - [see Brake's full reaction](#).*

## [Taxi reforms pose 'serious' risk to vulnerable children warn council leaders](#)

Children could be at greater risk of sexual exploitation under government plans to reform taxi licensing, town hall chiefs are warning. The Local Government Association (LGA) said proposals set out within the Deregulation Bill will make it easier for criminal gangs to use licensed vehicles to groom, abuse and traffic children.

## [Local and central government least trusted by staff, report finds](#)

Local and central government are the industries least trusted by their own staff, with 'budget cuts and upheaval' causing employee concern – a report claims. A survey of 1,600 UK managers by the [Institute of Leadership and Management \(ILM\)](#) found just 10% of central and local government employees – including the police and fire service – had 'high trust' in their organisations – the number of positive opinions charted minus the negative. This compares to 32% in education and 34% in financial services, banking and insurance.

The creation of a combined authority for Nottinghamshire has been condemned as a 'wacky and nonsense' idea by a key opposition leader. Nottinghamshire CC's Conservative group leader, Cllr Kay Cutts, argued that switching to unitaries would save between £50m and £90m a year.

## [Council care teams called in after slavery arrests](#)

A local authority is providing care to seven people following a police investigation into allegations of modern slavery. Lincolnshire Police together with neighbouring forces and the National Crime Agency arrested seven people at five locations around Lincoln and two other areas on Monday.

## [Key Cities publish 'bold' devolution charter](#)

England's cities should have pooled budgets and freedom to allocate funds as they see fit, according to proposals [outlined in a 'bold devolution charter'](#). The charter has been drawn up by Key Cities, a group representing 24 mid-sized cities including Southampton, Hull, Wolverhampton and Milton Keynes.

The Core Cities Group has warned communities will not accept 'half measures' over devolution in a strongly worded letter to Government. The group of 10 city leaders have written to William Hague, urging the Government to grant them devolved powers 'at the same speed' as Scotland.

## [Greater Manchester expands data sharing project](#)

Stockport and Tameside have become the latest councils to join a data-sharing scheme designed to help authorities engage local people and improve services.

## [Maintain support for 'armchair auditors', councils urged](#)

Councils have been urged to continue supporting 'armchair auditors' keep check on local authority spending once the national watchdog is disbanded. The Audit Commission launched its final update to provide members of the public with information on billions of pounds of town hall spending.
