The Immigration Bill has received Royal Assent making way for a series of reforms which will ensure our immigration system is fairer to British citizens and legitimate migrants and tougher on those with no right to be here. The Immigration Act 2014 contains 77 clauses and makes fundamental changes to how our immigration system functions.

## 2. Strategic policing and crime news

### [Home Secretary announces review of undercover policing cases](#)

Home Secretary Theresa May has announced details of a review of criminal convictions in cases involving undercover police officers. The review will look at whether convictions are safe in cases where undercover activity was not revealed to the prosecutor and therefore not considered by the court.

At their annual conference, the Association of Chief Police Officers has discussed proposals for a new co-ordinating body.

### [Forced marriage is now a crime](#)

Forcing someone to marry against their will became a crime on 16th June 2014 with a maximum penalty of seven years imprisonment.

### **ACPO comment on khat ban coming into force**

Enforcement of the khat ban will be firm but proportionate. Officers will take into account the nature of the offence and its severity, using a tiered approach towards offences relating to possession for personal use.

Home Secretary Theresa May and Policing Minister Damian Green attended an awards ceremony to recognise the dedication and hard work of special constables and police support volunteers. Police Support Volunteer – Individual Award: Chris Channon –

Nottinghamshire Police. The initial idea for Pegasus PIN number initiative was put forward by Chris, who has Cerebral Palsy, and had experienced problems when calling the Force and dealing with officers in person. His idea was to create a way of making it easier for people with disabilities/vulnerabilities to call Nottinghamshire police. The initiative has been developed and introduced across all three emergency services in Nottinghamshire.

- 21,657 people suffered serious injuries, 6% fewer than 2012 - that's 59 a day

## **New reports aim to help reduce accidents to children and young people in the home and on the roads**

Public Health England (PHE) have launched 2 new resources for local authorities on preventing accidents to children and young people in the home and on the road. The reports show whilst the number of children and young people killed or seriously injured continues to fall in England there are still significant numbers of deaths and emergency admissions from preventable causes. On average each year between 2008 to 2012, 525 children and young people under 25 died and there were more than 53,700 admissions to hospital. The reports highlight actions local partners can take to reduce accidents including improving safety for children travelling to and from school and using existing services like health visitors and children's centres.

The [Reducing unintentional injuries in and around the home among children under 5 Years](#) and the [Reducing unintentional injuries on the roads among children and young people under 25](#) reports include an analysis of data between 2008 to 2012.

## **Learner drivers to pay less for theory tests from October 2014**

The cost of the driving theory test will be cut by 25%, saving learner drivers in excess of £100 million over the next 9 years, Transport Minister [Stephen Hammond](#) has announced. The fee for a car driving theory test will fall by £6 in October 2014, taking the cost of a test from £31 to £25, with a further drop of £2 in October 2015. Theory test fees for motorcycles and other categories of vehicle will also be reduced. The changes have been confirmed following a public consultation.

## **Transport Committee to hold first evidence session for investing in the railway inquiry**

This is the first evidence session in the Transport Committee's Investing in the railway inquiry, which aims to scrutinise the impact and deliverability of Network Rail's £38 billion investment programme over the next five years (Control Period 5) and to identify priorities for investment after 2019. Likely topics for discussion include the extent to which the investment in Control Period 5 will reduce bottlenecks in the network, improve resilience and meet demands for greater capacity.

## **Transport Committee launch inquiry on motoring of the future**

The Transport Committee is launching an inquiry on motoring of the future. This inquiry will examine how the UK Government can address developments in motoring technology, notably alternative fuels, safety improvements and driver aids.

## **Public Accounts Select Committee - Inquiry**

England's strategic and local road networks are our most highly valued infrastructure asset, at around £344 billion. The two networks comprise over 187,000 miles of roads. They include more than 61,000 bridges, drainage systems, and numerous other features - such as embankments and retaining walls. This infrastructure supports 90 per cent of passenger traffic and 68 per cent of freight movements. Maintaining it so that it is safe, serviceable and reliable, is vital for the economy and the social well-being of communities. In response to the Spending Review 2010, the Department proposed to cut road maintenance budgets by £1.2 billion. The Department for Communities and Local Government planned to reduce its grant to local authorities by 28 per cent in real terms over the five-year period. In 2012, the Committee of Public Accounts report, Reducing costs in the Department for Transport,

concluded that the Department did not have a full understanding of budget reductions, and that these reductions risked higher long-term costs.

## **[Public sector borrowing up £4.6bn in May](#)**

Public sector borrowing in May was £13.3bn, up £4.6bn from the same month last year when it was £8.7bn, figures from the Office for National Statistics (ONS) have revealed. The Public Sector Finances, May 2014 report estimates that the monthly deficit increased due to there being no transfers from the Bank of England's Asset Purchase Facility Fund in the month. This is compared to last year when £3.9bn was transferred during May.

Employees who blow the whistle on wrongdoing in the workplace will receive more information and support under new measures to strengthen whistleblowing legislation announced by Employment Relations Minister Jenny Willott.

## **[Councils to be banned from widespread use of CCTV 'spy cars'](#)**

The government will make it illegal for councils to issue penalty charge notices to drivers using just closed circuit television (CCTV) 'spy cars' that currently patrol roads for on-street parking enforcement. One of a range of measures used to rein in 'over-zealous' parking

enforcement practices, the ban will now become law through the Deregulation Bill, following a three-month consultation.

## [Relaxing minicab licensing laws could be 'devastating' – LGA](#)

Plans to allow licensed drivers to let other people use their vehicle when they are off-duty – without any checks being carried out – could be 'devastating', the Local Government Association (LGA) has warned. Relaxing minicab licensing under the Deregulation Bill, which is at the Report Stage in Parliament, could pose a greater risk to public safety, according to the LGA.

## [Bedroom tax is 'fundamentally flawed'](#)

Research carried out by [University of Cambridge](#) revealed that bedroom tax does not take into account overall floor space in English homes. The university found during the course of its study that the majority of homes did not have enough floor space according to modern standards.

## [Councillors should ignore 'Stalinist' ban on media contact](#)

New guidance from the National Association of Local Councils (NALC) that tries to ban parish councillors from speaking to journalists without prior permission from officials has been castigated in the strongest terms by the government. NALC has written to 9,000 parish and town councils urging them to adopt the guidelines into their constitutions, meaning councillors who refuse to comply could be disciplined.

## [City Deal opens up billion pound investment in Cambridge](#)

The Cambridge City Deal, which could see up to £1bn pumped into the city's transport network, has been signed with the government.

## [Every council that bid for pothole cash gets a share](#)

All 148 local authorities that applied for funding through the government's £168m 'Repair the Pothole Fund' have been successful and will receive a share of the extra money, the DfT has revealed.

## [500 council staff take voluntary redundancy](#)

[Wolverhampton City Council](#) has announced that more than 500 people working for the authority have been approved for voluntary redundancy. The council plans to cut 2,000 jobs—a third of its workforce—over the next two years as part of austerity measures. The council has to find £123m worth of savings by 2018.

## [Audit Commission calls for improved 'accuracy' in grant claims](#)

The Audit Commission has called for "improved quality" and "accuracy" in grant and subsidy claims and returns by local authorities. This comes after 78% of councils' claims to the grant-paying body for housing benefit subsidies for 2012-13 were challenged by the Audit Commission's appointed auditors.

## [Universal Credit expanded into north west](#)

Universal Credit will be rolled out across the north west of England, but the total number of jobcentres offering the flagship scheme will still only total 90 – one in eight of the total across Britain.

## [Winning bids for government's £10m broadband fund announced](#)

The eight successful bids for the government's £10m innovation fund to explore ways to take superfast broadband to the most remote and hardest to reach places in the UK have been announced. The shortlisted pilots will explore how to expand coverage in remote areas, using fixed wireless and satellite technologies, a social investment financial model and an operating model which aggregates small rural networks, to ensure no-one is left behind in the digital slow lane. Successful bids include Wales (£847,650), North Yorkshire (£1,564,600), North Lincolnshire (£2,054,000), Northern Ireland and Scotland (£885,640), Devon and Somerset (£175,125), Hampshire (£1,194,145), Northumberland (£449,997) and Kent (£957,900).

## [Why we need smarter water management for the world's most essential resource – White Paper](#)

Around the globe, water is used for much more than just drinking. Water is essential for agriculture and for cooling and cleaning industrial equipment. ## 4. Consultations

### [Ministry of Justice seeks views on support for male sexual abuse survivors](#)

The Ministry of Justice (MOJ) is giving male survivors of sexual abuse a chance to have their say about the sort of support they'd like to receive. Earlier this year the government committed £500,000 to the first dedicated fund to support male victims of rape and sexual abuse. The MOJ is now asking for people's views to help shape how this new pot of money is spent. The dialogue closes on the 13<sup>th</sup> July.

### [Consultation into police use of pre-charge bail extended](#)

Police forces, stakeholders and members of the public now have an extra four weeks to comment on new principles to govern the use of this police power. The consultation now closes on 21st July 2014.

### [The Local Government Pension Scheme \(Amendment\) Regulations 2014: draft regulations on scheme governance](#)



This consultation on new governance arrangements, seeks responses from interested parties on the draft regulations which are to come into force from October 2014 onwards. This consultation closes on 15 August 2014.

## [Accounts and Audit Regulations consultation 2014 - earlier closure of accounts](#)

The Local Audit Consultation which **proposals include the earlier preparation and publication of the Statement of Accounts**. In January 2014, the Local Audit and Accountability Act received Royal Assent. Secondary legislation is needed to give effect to the new local audit arrangements and the consultation covers the detail of this. The Accounts and Audit (England) Regulations 2011 set out requirements on financial management, internal control, internal audit, the content of published accounts and procedures affecting the published accounts, public rights and the audit itself for all relevant authorities except health service bodies. New Accounts and Audit Regulations, to be made under Section 32 of the Local Audit and Accountability Act 2014, will play a similar role in the new local audit framework. One of the proposals is to bring forward, from 2017/18, the existing dates of 30 June and 30 September to 31 May and 31 July, for accounts being signed and certified by the Responsible Financial Officer and then approved and published. The consultation is open until **18 July 2014**.

## [Integrated inspections to assess the contribution of all professionals to the help, care and protection of children and young people](#)

The consultation launch of the targeted programme of integrated inspections. This marks a major step forward in the way that the contribution of local agencies is assessed with regards to the help, care and protection of children, young people and families. Under proposals published, from April 2015, Ofsted, the Care Quality Commission, Her Majesty's Inspectorate of Constabulary, Her Majesty's Inspectorate of Probation, and where appropriate, Her Majesty's Inspectorate of Prisons will work together to carry out a targeted programme of 'integrated' inspections. The consultation will run from 23 June – 12 September 2014 (12 weeks).

## [Traineeships: funding reform in England](#)

This is a joint consultation from the Department for Education and the Department for Business, Innovation and Skills. We are asking for views on how government funding for the traineeships programme in England can be used to deliver the best possible results for young people.

## [NICE quality standards – the process guide](#)

The second update to the process guide for developing NICE quality standards is now available for comment in draft form. Note that the process guide is provisional and may change after consultation. **Consultation dates: Tuesday 10 June - Wednesday 3 September 2014**

## [Reform of the Riot \(Damages\) Act](#)

Consultation on proposals to reform and modernise the Riot (Damages) Act 1886. The consultation will close on 1 August 2014.

## [Proposed changes to guidance on domestic violence](#)

The Director of Public Prosecutions, Alison Saunders, has proposed changes to the way the CPS considers domestic violence cases and has published draft guidance, which is out for consultation, that explains the impact of domestic abuse on different groups to help

prosecutors to adopt a tailored approach taking into account their particular support needs. The consultation is open until 9th July 2014.

## [Data policy for a Public Data Corporation](#)

Views wanted on how to provide accessible public sector information. The consultation will close on 27 October 2014.

## 5. Reviews and Inspections

### **East Midlands Commissioner's Commission HMIC Review**

The purpose of the commission is to provide the East Midlands regional police and crime commissioners assurance on the effectiveness and efficiency of managing counter terrorism funding arrangements through a single counter terrorism (CT) grant rather than through separate funding streams.

### [HMIC provides assurance that chief constables are having regard to the Strategic Policing Requirement – but finds that more needs to be done](#)

This inspection examined how well police forces have established the arrangements that the Strategic Policing Requirement requires them to have in place to counter a number of specified threats to national security and public safety. It is based on data and documentary evidence provided by all 43 police forces in England and Wales in July 2013. It includes supporting fieldwork, conducted in 18 forces, and in nine Regional Organised Crime Units (ROCs).
