### [Damian Green speech on excellence in policing](#)

Speech given by Damian Green at the ACPO Excellence in Policing in Ryton. "The old ways of ticking the boxes for the targets are gone. I want the police to be responsive to the needs and desires of the people you serve, not Whitehall whims. Cutting costs is good, it is other people's money you, and I, spend. But that is not the 'point' of our policing reforms. Police have to use their judgment, good judgement, all the time. That judgment – whether to arrest or caution for a low-level vehicle crime, or whether someone caught cycling on a pavement needs a telling-off or a fixed penalty notice – is always crucial and always builds towards the one overriding aim of cutting crime. Officers must judge what the right thing to do is, but of course always within the confines of the law."

Police led prosecutions pathfinder areas. The nine pathfinder areas are:

- Essex
- Hampshire
- Kent
- Lincolnshire
- Metropolitan Police Service
- Nottinghamshire
- Norfolk
- Suffolk
- West Yorkshire

All pathfinder areas adopted a core model for police-led prosecutions, covering dedicated traffic courts, centralised case management, and improved communications between October and December 2012. In most pathfinder areas the police began prosecuting new offences, exceptional hardship and proof in absence cases by January 2013.

Scientists and government officials from 195 countries have been meeting all week ahead of the publication from the UN-sponsored Intergovernmental Panel on Climate Change (IPCC).

Release from the Office of National Statistics:

- In 2012 there were estimated to be 465,500 people aged 90 and over living in England and Wales, just under 1% of the total population.
- Between 2002 and 2012 there has been a 33% increase in the number of those aged 90 and over.
- In 2012 in England and Wales, the number of centenarians (those aged 100 and over) was estimated to be 12,320.
- There were estimated to be 2.6 women per man aged 90 and over and 5.9 women per man aged 100 and over in England and Wales in 2012.

## **Business Register and Employment Survey, 2012**

Release from the Office of National Statistics:

- The level of employees in the UK showed an increase of 0.5% between September 2011 and September 2012.
- The number of UK full-time employees increased by 30,000, while the number of part-time employees increased by 96,000.

## **Labour Productivity, Q2 2013**

Release from the Office of National Statistics:

- On an output per hour basis, UK labour productivity increased by 0.5% in the second quarter of 2013. Market sector productivity increased by 0.6% over this period.

**Councils should create more 20mph zones – DfT** - Transport minister Norman Baker has urged more councils to implement 20mph zones and to take advantage of new freedoms to make their own decisions on sign lighting and removing 'signage clutter'.

## **4. Consultations**

### **Local Government Finance Settlement 2014-15 and 2015-16: technical consultation**

The closing date for consultation responses is 2 October.

**Sentencing Council Launches Public Consultation on the Sentencing of Fraud, Bribery and Money Laundering Offences** - The consultation closes on 4 October 2013.

### **Drinkaware call for evidence on binge drinking**

Drinkaware is launching a review in support of the Government's Alcohol Strategy to develop a coherent, well evidenced strategy with regard to the role that Drinkaware could play in reducing the harm from public drunkenness and its negative consequences. The consultation runs until 11th October.

**Consultation on prescription drug tramadol** - The deadline for responses is 11 October 2013.

### **Greater flexibility for change of use**

In order to support the Government's priorities for making better use of existing buildings a consultation on proposed changes to planning regulations has been launched and will run until 15 October.

### **Public sector procurement changes to help SMEs win business**

The Government has published its consultation on making public sector procurement more accessible to SMEs – which could mean every public sector organisation having to use the same pre-qualification questionnaire as central Government. The consultation closes on the 17 October.

## **[Alcohol fraud: next steps](#)**

This consultation provides further details and seeks views on the next steps the Government plans to take to tackle existing and emerging threats to the UK alcohol duty regime. The consultation runs until 28 October.

## **Conducting Privacy Impact Assessments Code of Practice consultation**

The ICO is consulting on its draft '[Conducting privacy impact assessments code of practice](#)' and would like to hear views. The deadline for responses is 5 November.

## **[Needle and syringe programmes \(update\): guideline consultation](#)**

NICE is conducting an update of [NICE public health guidance 18 \(2009\)](#). The updated guidance has been extended to focus on providing needle and syringe programmes (NSPs) for young people aged under 16 who inject drugs and users of performance and image-enhancing drugs. The consultation closes on the 5 November.

## **[Do drug and alcohol workers need a Voluntary Professional Register?](#)**

Skills for Justice is carrying out a consultation and are seeking views of practitioners, employers, membership organisations, commissioners of services and policy makers.

## **[Biodiversity offsetting in England](#)**

Biodiversity offsetting ensures that when a development damages nature (and this damage cannot be avoided) new, bigger or better nature sites will be created. This consultation sets out proposals for biodiversity offsetting and how it might be introduced in England. The consultation provides an overview of biodiversity offsetting, explores how it might operate, and introduces the key issues that would need to be addressed. The consultation is open until 7 November 2013.

## **[Registration of providers of social work services](#)**

In January and February of this year, the department consulted on proposals to commence part 1 of the Children and Young Persons Act 2008 (CYPA).

## **[Data sharing between public bodies](#)**

The Law Commission has published a consultation paper on the subject of data sharing between public bodies. The project aims to establish whether the perceived obstacles are embedded in practice or culture, or whether they are to do with the substance of the law and how it is written. The consultation will run until 16th December 2013.
