2. Policing and crime key developments

[Ten minute rule motion on Domestic Violence](#)

That leave be given to bring in a Bill to make provision for the investigation of allegations of domestic violence, for duties on the police in respect of domestic violence, for risk assessment and training in connection with related criminal proceedings in England and Wales; and for connected purposes.

[Domestic violence and abuse: how health services, social care and the organisations they work with can respond effectively](#)

Domestic violence and abuse is a complex issue that needs sensitive handling by a range of health and social care professionals. The cost, in both human and economic terms, is so significant that even marginally effective interventions are cost effective. Women and men can experience this type of violence in heterosexual and same-sex relationships.

The recommendations cover the broad spectrum of domestic violence and abuse, including violence perpetrated on men, on those in same-sex relationships and on young people. Working in a multi-agency partnership is the most effective way to approach the issue at both an operational and strategic level. Initial and ongoing training and organisational support is also needed.

The guidance is for health and social care commissioners, specialist domestic violence and abuse staff and others whose work may bring them into contact with people who experience or perpetrate domestic violence and abuse. In addition it may be of interest to members of the public.

MEPs step up effort to fight forced prostitution and trafficking of women

The European Parliament today urged EU governments to step up efforts to fight forced prostitution and trafficking of women, in a resolution drafted by S&D Euro MP Mary Honeyball. At least 62% of trafficked women become victims of sexual exploitation according to official data published in April 2013 by the European Commission. Many of those victims are from EU countries and many are very young.

- whether its financial governance arrangements provide sufficient assurance to members and stakeholders that the Federation's expenditure represents value for money; and
- how the Federation might adapt to better meet current challenges, including the introduction of the new landscape of policing and the impact of changes to members' pay, pension and terms and conditions of employment.

This will sit alongside £4.4 million dedicated to provide 78 female rape support centres across England and Wales with financial support through to 2016 so they can offer specialist services for victims such as counselling, advice and helplines. The Ministry of Justice will also be establishing two new rape support centres in the coming year, on top of the 13 set up since 2010, meeting the Coalition commitment to open 15 new centres.

[High central costs in some councils need greater scrutiny says Audit Commission](#)

The Audit Commission has published new analysis of data on English councils' central management costs in its briefing, *Councils' Centrally Managed Spending: Using Data From the Value for Money Profiles*. Overall spending on corporate and democratic management⁽¹⁾ reduced by 13 per cent from 2003/04 to 2012/13, while spending on central management support to services⁽²⁾ increased by 10 per cent. However, gaps and inconsistencies in councils' recorded spending in these areas will, the Commission says, hinder councils' attempts to identify savings and undermines accountability to taxpayers. As a result, the Commission is calling for greater local scrutiny and more consistent reporting by

councils of their central management spending.

The government is awarding £1.5m to encourage the opening up of public sector data. The Open Data User Group (ODUG) is released 50 case studies on open-data-led business and applications on data.gov.uk, the government's flagship data portal.

Net migration rose by more than a third to 212,000 in the year to September, according to the Office for National Statistics. The rise of 58,000 immigrants, mostly from the European Union, means that Government immigration targets of 100,000 are unlikely to be met (*FT*; *Telegraph*; *Times*; [BBC Online](#)).

The Government has confirmed yesterday that it will move ahead with planned cuts to the criminal legal aid budget. The Government is planning to cut the budget by £220 million with barristers and solicitors planning a walk out in March in protest ([FT](#)).

The Low Pay Commission has recommended a 3 per cent increase in the minimum wage to £6.50 an hour. The proposed rise would increase the number of jobs covered by the minimum wage by more than a third, to approximately 1.25 million (*FT*; [BBC Online](#)).

Private groups have been invited to help the National Health Service buy services for the first time. The NHS has asked for companies to compete for work advising NHS England on patient care reforms, negotiating hospital contracts, supporting organisational change and outsourcing services (*FT*).

The Commons Health Select Committee raised concerns about the performance of Public Health England since its inception last year. A report by the committee states that Public Health England “has not yet shown that it is able to be an effective champion of the nation’s public health interests” (*Guardian*).

Labour will pledge to ‘de-clutter’ public services in a speech to be given by Chris Leslie MP. In a speech to be given at the Social Market Foundation, Chris Leslie MP, Shadow Chief Secretary to the Treasury, will pledge to ‘de-clutter’ public service provision by streamlining bureaucracy and encouraging the merger of local bodies in order to save money (*FT*; *Times*; *Independent*; [BBC Online](#)).

The Crown Prosecution Service (CPS) has cut the number of staff employed to look after the witnesses by 57 per cent in the past three years. According to a research by the Bureau of Investigative Journalism, Witness Care staff numbers fell by 24 per cent last year, though the CPS claims that drop is the result of the consolidation of Care Units and greater responsibility being taken by the police (*Independent*).

The National Audit Office (NAO) has reported that over three quarters of the Government Regional Growth Fund remains unspent. The NAO reported that although the number of jobs created has almost doubled since 2012, the cost of creating these new jobs has also increased by 13 per cent (*Times*; [BBC Online](#)).

The second largest chain of state-funded academies, E-Act, is to lose control of ten schools, according to the Department for Education. The decision follows concerns raised by Ofsted inspectors about the schools’ performances, and the Department for Education is looking for new sponsors for the schools (*Telegraph*; [BBC Online](#)).

The British Chambers of Commerce (BCC) has called on Chancellor George Osborne MP to include in the budget measures focusing on youth unemployment and

training. Along with the proposed introduction of a £1,000 grants for business that employ young people, other measures suggested by the BCC include increasing the tax relief available on the Enterprise Investment Scheme (*FT*; [BBC Online](#)).

The Local Government Association (LGA) has called for ministers to rethink their decision to end the £345 million Local Welfare Assistance Fund. According to the LGA, the abolition of the fund, which is typically spent on food, clothing and accommodation, could leave councils unable to support families who suddenly face emergencies (*Independent*; [BBC Online](#)).
