Overall, it has delivered just £2.5bn of savings on social security spending since 2010.

The one-year anniversary of Target's 2013 Black Friday data breach, it doesn't appear that shoppers are shying away from shopping via credit or debit cards to avoid a similar predicament this year. In fact, a new study by Deloitte found that 56 percent of consumers will shop at retailers that have experienced a data breach this past year, including Target, Home Depot, Kmart and Michaels, even though 42 percent said they are concerned about their personal data.

Local government expects to save more than £670m by embracing the Digital by Default agenda, according to a new survey of senior executives. The Public Sector Channel Shift Strategies Survey Report 2015 by GOSS Interactive reveals that moving to online channels

such as web and social media is expected to councils around £1.55m each next year, an increase of 345% in 2014.

Proposals to amend regulations relating to the use of capital receipts
