1. Legislation

[Police Reform and Social Responsibility Act 2011 Amendments](#)

The Police Reform and Social Responsibility Act, which has been updated to reflect the latest amendments. The amendments are:

- [Anti-social Behaviour, Crime and Policing Act 2014](#) (Prospective – the provisions in Sch.11 as they relate to the PRSR2011 are not yet in force).
- [Local Audit and Accountability Act 2014](#) (Prospective – the provisions as they relate to the PRSR2011 are not yet in force).
- [Crime and Courts Act 2013](#) (The provisions as they relate to the PRSR2011 came into force 7th October 2013 by [S.I. 2013/1682 art. 3\(v\)](#) The Crime and Courts Act 2013 (Commencement No. 2 and Saving Provision) Order 2013).
- [Localism Act 2011](#) (The provisions as they relate to the PRSR2011 came in force 3rd December 2011 by [S.I. 2011/2896 art. 2\(i\)](#)) The Localism Act 2011 (Commencement No. 1 and Transitional Provisions) Order 2011.

[Offender Rehabilitation Act 2014](#) – Received Royal Assent on 13 March.

The Offender Rehabilitation Bill today received Royal Assent. It provides many of the measures which underpin the Transforming Rehabilitation programme.

[Criminal Justice and Courts Bill](#)

This Government Bill was presented to Parliament on **5 February 2014**. The Bill had its second reading debate in the House of Commons on **24 February 2014** and considered in a Public bill Committee on **25 March 2014**. The Public Bill Committee is expected to report by **1 April 2014**. The Bill is to make provision about how offenders are dealt with before and after conviction; to amend the offence of possession of extreme pornographic images; to make provision about the proceedings and powers of courts and tribunals; to make provision about judicial review; and for connected purposes.

[Report stage \(Lords\) \(Day 1\) of the Immigration Bill - April 1](#)

The **Immigration Bill** had its first day of report stage in the Lords. Further progress will be made on April 3.

[Second reading \(Commons\) of the Finance \(No. 2\) Bill - April 1](#)

The Finance (No. 2) Bill was given a second reading in the Commons and now goes to committee for further consideration.

[Children and Families Act 2014 receives Royal Assent](#)

The new Children and Families Act - given royal assent today - will mean changes to the law to give greater protection to vulnerable children, better support for children whose parents are separating, a new system to help children with special educational needs and disabilities, and help for parents to balance work and family life.

[International Development \(Gender Equality\) Act](#)

Received Royal Assent to promote gender equality in the provision by the Government of development assistance and humanitarian assistance to countries outside the United Kingdom; and for connected purposes.

[The Police Act 1997 \(Criminal Records\) \(Amendment\) Regulations 2014](#)

These Regulations came into force on 10th March 2014. These Regulations insert a new regulation in the Police Act 1997 (Criminal Records) Regulations 2002 to prescribe a fee in relation to an application for the issue of a criminal conviction certificate within the meaning of section 112 of the Police Act 1997. These Regulations also prescribe the details to be provided in relation to a conditional caution and conviction disclosed under section 112 of the Act. Finally, these Regulations prescribe the meaning of 'central records', which are the records where convictions or conditional cautions are held for the purposes of section 112 of the Act.

SI 2013/3183 The Criminal Procedure (Amendment No. 2) Rules 2013 - Rule 7 of these Rules came into force on **24 February 2014** and rules 4, 5, 6, 8 and 9 will come into force on **7 April 2014**.

SI 2014/260 The Road Traffic Offenders (Additional Offences) Order 2014 - This Order came into force on 1 April 2014.

SI 2014/259 The Fixed Penalty (Amendment) Order 2014

This Order came into force on 1 April 2014. It applies in relation to a fixed penalty offence alleged to have been committed on or after 1 April 2014.

SI 2014/264 The Road Vehicles (Construction and Use) (Amendment) Regulations 2014 - These Regulations came into force on 1 April 2014.

SI 2014/478 Crime and Security Act 2010 (Commencement No. 7)

Order 2014 - This Order brings into force sections 24 to 31 of the Crime and Security Act 2010 on 8 March 2014 across police forces throughout England and Wales.

SI 2014/633 The Criminal Justice Act 2003 (Commencement No. 32) Order 2014

This Order brought into force on 1 April 2014 the provisions in sections 29 and 30 of the Criminal Justice Act 2003 so as to allow the Driver and Vehicle Standards Agency (DVSA), a new executive agency of the Department of Transport, to institute criminal proceedings by issuing a written charge and requisition.

[The Chief Inspector of Constabulary publishes his first annual assessment of policing](#)

State of policing: the annual assessment of policing in England and Wales 2012/13

HM Chief Inspector of Constabulary, Tom Winsor, has published his annual assessment of the efficiency and effectiveness of policing in England and Wales. The assessment covers the full breadth of policing work inspected by HMIC throughout 2012/13, and an overview of police forces in England and Wales. The report opens with an essay by HM Chief Inspector, on his thoughts on policing for the last year drawing on his experience in his role, and HMIC inspections. The essay addresses the financial challenge faced by forces, the demand for the services of the police and the changing nature of crime, crime prevention, the role of police and crime commissioners and HM Inspectorate of Constabulary's role in inspecting forces.

ACPO comment on HMIC State of Policing report

HMIC's annual assessment summarises the complex challenges that policing must grapple with: how to find further efficiencies and savings within constrained budgets, how to protect the public against national and international threats across force boundaries and how to optimise consistency in systems and IT across 43 forces.

The bidding process for the £50m Police Innovation Fund for 2014/15 has opened with the publication of the bidding form and assessment criteria. Police and Crime Commissioners need to submit their applications by 5pm on 30 April. The bids will be assessed against the following four criteria:

- Transform policing through innovation
- Enhance collaboration
- Deliver efficiencies
- Be locally owned and monitored

Bids need to set out how they meet the above criteria (with a maximum of 300 words for each).

3. Developments and reports

[Final Report Published: Review of IPCC's Work in Investigating Deaths](#)

The Independent Police Complaints Commission (IPCC) has published a major report into the way it investigates deaths, signalling changes in approach and procedure, including ensuring the effective engagement of families. The report follows a wide-ranging review, launched in autumn 2012 in response to a number of critical cases and feedback from families, individuals and organisations. The findings focus on independence, the conduct of investigations, and engagement with families and police officers.

Within the Criminal Justice Strategy and Action Plan, the Ministry of Justice committed to conduct a review of ways to reduce distress for victims in sexual violence trials. The review report has been published. Among the recommendations are: to develop more specialised case management for sexual violence cases, improve the special measures available to victims, and, to consider use of reserve jurors to ensure that cases are not repeated/delayed due to juror absence.

Commons debate on Prevention and Suppression of Terrorism - April 3

The Minister for Security and Immigration (James Brokenshire): raised that the Terrorism Act 2000 (Proscribed Organisations) (Amendment) Order 2014, which was laid before this House on 31 March, be approved.

The Criminal Injuries Compensation Authority (CICA) has become an Executive Agency of the Ministry of Justice. CICA was established in 1994 with the core function of paying money to people who have been physically or mentally injured because they were the blameless victim of a violent crime. The creation of CICA as an Agency will not lead to any change in the organisation's core function. CAFCASS (Children and Family Advisory and Support Service) have also become a part of the Ministry of Justice, moving from Department of Education.

An increasing number of local authorities are making use of schemes to share services, relating to both 'back office' and 'front line' functions. Some of these have taken the form of shared services or shared staff between a number of authorities, not always those bordering one another. The best known of these is probably the 'Tri-Borough' arrangement between Hammersmith and Fulham, Westminster, and Kensington and Chelsea. The Local Government Association has published research showing that shared services are being used by a majority of councils in England, but it has warned that sharing services will be unable to make up fully for the reductions in funding to local authorities.

The Minister of State for Policing and Criminal Justice (Damian Green): The Government has decided to opt in to the Member State Initiative for a Regulation of the European Parliament and of the Council to relocate the European Police College (CEPOL) from Bramshill (UK) to Budapest (Hungary) (European Union Document Nos. 2013/0812 (COD), ENFOPOL 395 CODEC 2773 PARLNAT 307).

[Reforms Report – Solving the NHS care and cash crisis.](#)

The comprehensive plan argues that tackling the “care crisis” requires the NHS to turn into a “National Health and Care Service (NHCS), based on a new partnership between State and citizen, with integrated health and social care available locally in the community and consolidation of hospital specialist services on fewer sites of higher quality”. The report, published by the independent think tank Reform, proposes an NHS Membership scheme for all UK residents, including an annual health MOT to set new responsibilities each year for both the NHS and the individual.

A new draft Bill, published by the law commission, will enable health regulators to bar foreign medical professionals who cannot speak English from practicing and subject them English language tests.

The move follows warnings from MPs and peers that the current system has compromised patient safety (*Telegraph*).

Chancellor of the Exchequer, George Osborne MP, has revealed that the creation of a million new jobs by the end of the decade will form key part of the Conservative 2015 election pitch.

In a speech given in Essex yesterday, Mr Osborne claimed that “unemployment is never a price worth paying” and that “there is no reason why Britain shouldn’t aim to have the highest employment rate of any of the world’s leading economies” (*FT*; *Times*; *Guardian*; *Independent*; [BBC Online](#)).

Ministers are set to introduce changes to trespass laws in order to allow companies to exploit shale gas reserves under privately owned properties.

The energy industry is demanding the changes, which are set to be unveiled in the Queen’s Speech, before it invests hundreds of millions of pounds in assessing the economic viability of full-scale exploitation of Britain’s natural gas reserves (*Times*).

A report from the Organisation of Economic Cooperation and Development (OECD) has shown that English students are “more practical than academic”.

The OECD study of 44 nations concludes that, despite lagging behind other developed nations in literacy and numeracy standards, English students are amongst the best in the world at problem solving (*Independent*).
