## 1. Legislation

### [The Prison \(Property\) Bill receives Royal Assent](#)

This bill will allow prisons to destroy, recycle, sell or donate illicit mobile phones and other unauthorised items found in the possession of prisoners. The proceeds will go to charity or other suitable organisations.

[Arbitration and Mediation Services \(Equality\) Bill](#) - A Bill to make further provision about arbitration and mediation services and the application of equality legislation to such services; to make provision about the protection of victims of domestic abuse; and for connected purposes.

### [Coroners and Justice \(Amendment\) Bill](#)

A Bill to amend section 62 of the Coroners and Justice Act 2009 (possession of prohibited images of children) to apply additionally to the possession of prohibited written material about children; to make consequential amendments to the Act; and for connected purposes.

### [Crime and Courts Bill](#)

Provides for the establishment of the National Crime Agency (NCA) to prevent and investigate serious, organised and complex crime, enhance border security, and tackle the sexual abuse and exploitation of children, and cyber crime.

### [Justice and Security Bill](#)

A bill to provide for oversight of the Security Service, the Secret Intelligence Service, the Government Communications Headquarters and other activities relating to intelligence or security matters; to provide for closed material procedure in relation to certain civil proceedings; to prevent the making of certain court orders for the disclosure of sensitive information; and for connected purposes.

## [Home Office Circular 3/2013: New Government Domestic Violence and Abuse Definition](#)

The Home Office has published Home Office Circular 3/2013 'New government domestic violence and abuse definition'. The Circular advises readers that from 31 March 2013 a new definition of domestic violence and abuse will be implemented.

## [Home Office Circular 4/2013: Change to the Misuse of Drugs Act 1971](#)

This circular advises of a change to the Misuse of Drugs Act 1971 in the control of synthetic cannabinoids, methoxetamine and other related compounds, and O-desmethyltramadol.

The Home Affairs Committee (HAC) has published its report 'The draft Anti-social Behaviour Bill: pre-legislative scrutiny'. The report outlines the HAC's consideration of the draft Bill, and makes conclusions and recommendations.

Drug driving is a menace on our roads with an estimated 200 drug driving-related deaths a year in Great Britain. The Government has a zero tolerance approach to illegal drug use and it is important that we send the strongest possible message that you cannot take illegal drugs and drive.

## 2. Policing and crime key developments

### [Violence against women must be challenged and opposed:](#)

Home Secretary Theresa May explains why she is determined to make violence against women 'utterly unacceptable'.

### [Giving Victims a Voice Report](#)

Police and the NSPCC outlined offences by the late presenter at venues including 13 hospitals and a hospice. Some 214 crimes were recorded across 28 police force areas, including 34 of rape or penetration, the report said.

### [Criminal Justice Response to child abuse](#)

In recent years, both the police and prosecutors have put a great deal of effort into improving the investigation and prosecution of sexual offences, particularly those involving children. Many police forces now have specialist units to deal with these cases, staffed by specially trained officers. Strategies and techniques have improved and policy and guidance have been progressively tightened and improved.

### [Public to get clearer picture of how crime is recorded](#)

More detailed crime categories are being introduced to give the public a clearer picture of how police are tackling crime. Under the current system, 70 per cent of crimes are recorded

as 'undetected', leaving victims and the public concerned that nothing has been done by police.

Crime Prevention Minister Jeremy Browne said: 'High-quality scientific advice is vital to the government's ongoing work to tackle harmful drug use. The independent advice we receive from the ACMD is critical to our evidence-based drugs policy.*

### [Sale of Fire Service College completed:](#)

*The sale of the college to Capita has been complete. Fire Minister Brandon Lewis has announced the completion of the sale of the Fire Service College to Capita. The minister said that the college has at long last been given the best possible chance to fully realise the huge potential for this world-class asset.*

### **New data shows Britain's small businesses are still struggling to receive sufficient lending despite Government initiatives to ease credit conditions.**

Bank of England figures show that interest rates on loans to small businesses rose in January to their highest levels since late 2008 whilst figures from the British Bankers' Association reveal that the value of new loans to the country's small companies fell to £1.47 billion in the final quarter of 2012, from £1.62 billion a year earlier ([Telegraph](#); [Guardian](#); [BBC online](#)).

of female inmates are frequently overlooked in UK prisons, putting them at greater risk of re-offending.

## [Statistics on Youth Justice in England and Wales](#)

The Youth Justice Board and the Ministry of Justice have published 'Youth Justice Statistics 2011/12: England and Wales'. The statistics bulletin examines the youth justice system (YJS), considering the number of young people in the system, their offences and the outcomes. 'Young people' means people aged under 18. Most of the statistics relate to the year 2011/12; this runs from 1 April 2011 to 31 March 2012.

## [Road Traffic Casualties: Provisional Estimates](#)

The Department for Transport has published 'Reported Road Casualties in Great Britain: Quarterly Provisional Estimates 2012 Q3'. The statistical release gives estimates of personal-injury road accidents and their casualties, which were known to police within 30 days. Figures relate to the year ending September 2012.

## **Research shows perceptions of employment law do not reflect reality**

Business perceptions of employment legislation is at odds with the actual impact of legislation according to a new government commissioned study published today by Employment Relations Minister Jo Swinson. [The Employer Perceptions and Impact of Employment Regulation](#) study found that businesses that view employment law as burdensome often did so because of a lack of understanding of the law. Dismissal processes in particular were seen as stressful and costly with some employers going beyond legal requirements in the mistaken belief that such action was necessary.

## **Implementing a model for funding social care, Lord Norman Warner, previously a Commissioner on the Commission on Funding of Care and Support, has written an article for *Guardian Professional* on the cap on care costs recommended by the Dilnot commission.**

He writes: "The cost of implementing the new legislation is still murky and there is much scepticism about whether adequate funding will be available. Alongside this is the shortfall in funding of the current system and the impact of this on the availability and quality of services" ([Guardian](#)).

## **[‘Perverse’ bedroom tax means £100m disability spending gap](#)**

Disabled and vulnerable people must be exempt from the bedroom tax, the National Housing Federation has told the Government. Support pledged for those who will be hit by the bedroom tax through the fund for Discretionary Housing Payments (DHPs) has left a gap of over £100m for disabled people.

The latest survey of local authority websites by Socitm urges senior leaders to "get actively involved in the governance of digital delivery". The headlines results from [Better Connected 2013](#) are publicly available, but the detailed findings are limited to Socitm Insight subscribers. It contains assessments of all 433 local authority websites.

## **[New shared services contract for Department for Transport](#)**

The Government is establishing the first independent shared service centre to cut the cost of back office functions and save up to £600m a year. The seven-year contract with arvato covers the management of the Independent Shared Services Centre 1 (ISSC1), created from the existing DfT shared service centre in Swansea. The contract includes an optional three year extension and could eventually include provision of HR, procurement, payroll and financial transactional services to multiple government departments and arms length bodies.

**Legal aid: Criminal case cuts planned:** Plans to make further savings to the £2bn bill for legal aid in England and Wales have been announced by Justice Secretary Chris Grayling. Consultation on plans to cut criminal case costs, including lawyers competing for contracts, starts in April. Savings of up to £350m have already been earmarked by removing legal aid for a range of civil cases including those involving social welfare debt, employment, family problems, clinical negligence, divorce and housing problems.
